- 17. BNET Clinical Cx Trx Plan Treatment Plan: The service goals and objectives are based on the results of the intake assessments and include the concerns of the enrolled child and his family.
- 18. BNET Clinical Cx Trx Plan The plan shall include evidence that the child and family, consistent with the statutes and rules of the department for family involvement, has been included in the development of the treatment plan.
- 19. BNET Clinical Cx Trx Plan Treatment Plan: Developed within 10 working days of enrollment into the Behavioral Health Network for each enrolled child.
- 20. BNET Clinical Cx Trx Plan Treatment Plan: The plan shall be reviewed and updated no later than ninety (90) days apart.
- 21. BNET Clinical Cx Trx Plan Treatment Plan: The plan shall include evidence that the child and family, consistent with the statutes and rules of the department for family involvement, has been included in the development of the treatment plan.
