1. MH ALF Cx Assessment (394.4571.2.a) Assessed and determined to be appropriate for ALF by:
Psychiatrist or Clinical Psychologist
Clinical Social Worker
Psychiatric Nurse
Or individual supervised by one of the above listed
OR Discharge evaluation from State Mental Hospital completed 90 days prior to ALF admission fulfills this requirement.

2. MH ALF Cx Assessment (394.4571.2.a) Provided to Facility Administrator within 30 days after MHR's admission.

3. MH ALF Cx Case Management (394.4574 (2)e)) CM is assigned to each MHR.

4. MH ALF Cx CLSP (394.4574 (2)(e)) CLSP updated annually

5. MH ALF Cx CLSP (429.02(7) 429.075 (3) 58A-5.029 FAC) CLSP includes information about:
5. Other services provided or arranged by ALF

6. MH ALF Cx CLSP (429.02(7) 429.075 (3) 58A-5.029 FAC) CLSP includes information about:
6. Factors pertinent to the care, safety and welfare including signs/ symptoms that indicate immediate need for mental health services.

7. MH ALF Cx CLSP (58A-5.029 (2)(c) (3) FAC) CLSP completed and given to the ALF administrator within 30 days of admission or within 30 days after received the Placement Assessment.

8. MH ALF Cx CLSP (394-4574 (2)(c)) Provider has a copy of the CLSP for each MHR in the ALF-LMF? (The CLSP and the Cooperative Agreement may be in one document)

9. MH ALF Cx CLSP (394.4574(2)(c); 58A-5.029 FAC) "CLSP was prepared and signed by:
1. MHR (if refusal, documentation of refusal is found)
2. Case Manager
3. ALF administrator, or the administrator's designee."

10. MH ALF Cx CLSP (429.02(7) 429.075 (3) 58A-5.029 FAC) The CLS Plan includes information about:
1. The specific needs of the resident

2. Specific services (including frequency and duration) to be provided by ALF

3. Other services / activities (including frequency and duration) to be provided by mental health provider

13. MH ALF Cx CLSP (429.02(7) 429.075 (3) 58A-5.029 FAC) CLSP Includes Information about:
4. Obligations of the ALF to assist / facilitate Resident attending appointments

14. MH ALF Cx Coop. Agreement (394.4574 (2) (b)) Provider has a current copy of the Cooperative Agreement signed by the provider and the ALF-LMH administrator (Agreement may cover all residents; verify ALF-LMF licensure)
15. MH ALF Cx Coop. Agreement (394.4574 (2) (b)) The Cooperative Agreement specifies directions for accessing emergency and after hours care for MHR.
16. MH ALF Cx Eligibility (394.4571.1) Client meets Mental Health Resident (MHR) definition (Receives SSDI OR SSI and Optional State Supplementation (OSS)).
