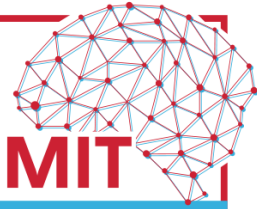

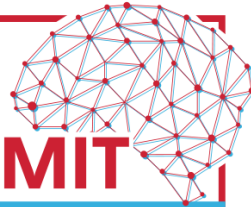

# Project SETS: Screen, Engage, Treat for Success

- Program Model:
  - Meet with overdose patients in the Emergency Department
    - Meeting them where they are, physically and emotionally
  - Called in by Nurses, Law Enforcement, EMTs
  - Screen and offer appropriate services
    - Including transportation to a detox facility with an available bed
  - Client does not need to go to the clinic to receive peer services
  - Harm Reduction Approach
  - Reduce barriers to treatment continuation
  - Increase Social Capital
    - Link to Recovery Community Organizations (RCOs) and other community supports



# Program Achievements

## Original Project Locations:

- At the conclusion of the three-year period, the project served 1,258 unique individuals with a total of 1,317 referrals. Original goal was to serve 600 individuals.
- Of the individuals served by the program, 98% of clients served did NOT have an opioid overdose revisit to the Emergency Department within 12 months after program discharge.
- In that same population, 65% of clients served did NOT have a substance use related Emergency Department revisit within 12 months after program discharge.



# Program Achievements

- 1600+ clients have been engaged with the program
  - Of those clients, 800+ have elected to work with a Certified Peer Recovery Specialist.
- In Lake Co, Emergency Room admissions decreased by 47.56% for clients engaged with the program, including data measured during the height of the pandemic.
  - The average cost of a client ED visit in Florida with an ICD10 code of a Poisoning/Adverse Events is \$ 5,337.85
- Clients who are engaged with Peers while in treatment in our program stay engaged an average of 56 days longer than those working only with a peer and 32 days long than those only enrolled in traditional treatment.



# Program Achievements

- SBIRT Train the Trainer
  - 37 staff have been trained as SBIRT trainers (Screening, Brief Intervention, Referral to Treatment)
  - 104 Medical Professionals have been trained to administer the SBIRT assessment.
- 18 Peer Recovery Specialists have been trained for Certification
- Additional local Clinic Contracts obtained included the Health Department, OBGYN Clinics, HIV Clinics, low-income community primary care clinics.

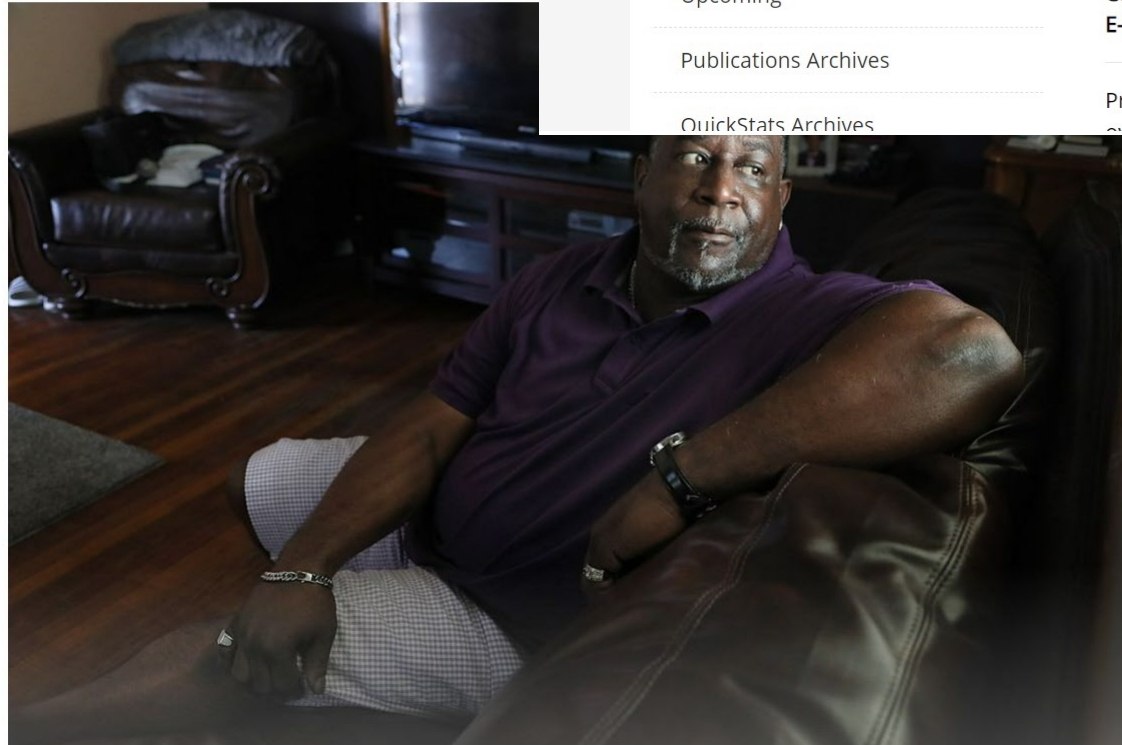

## Introducing.... SAMHSA SBIRT Grant! An extension of Project SETS!

Screen	Help identify potential problematic behavior with alcohol or drug use through standardized screening tools.
Intervene	Through brief intervention / offer resources (treatment, education, community supports).
Hope	Offer hope that help is available, and recovery is possible!

- 5 Year Grant Award
- \$1,000,000 per year
- Conduct screenings on all patients in the identified medical clinic partner sites.





# Grant Objectives

Minimum of 25,000 individuals  
will be screened by end of  
grant.

Increase # of community  
settings where SBIRT services  
are provided by at least 5 sites.

At least 30% of youth and  
45% of adults who are  
referred for brief treatment  
or specialty treatment will  
successfully engage in those  
services.

85% will show evidence of  
reduced alcohol and other  
drug use with 6 months of  
screening.

# SBIRT Screening Tools

## Screening, Brief Intervention and Referral to Treatment (SBIRT)

### Adults: AUDIT, DAST, PHQ-9 with GPRA

Alcohol Use Disordered Identification Test , Drug Abuse Screening Test, Patient Health Questionnaire- 9, Government Performance and Results Act

### Adolescents: S2BI, CRAFFT, PHQ modified for adolescents with GPRA

Screening to Brief Intervention, Car Relax Alone Forget Friends Trouble, Patient Health Questionnaire-9, Government Performance and Results Act



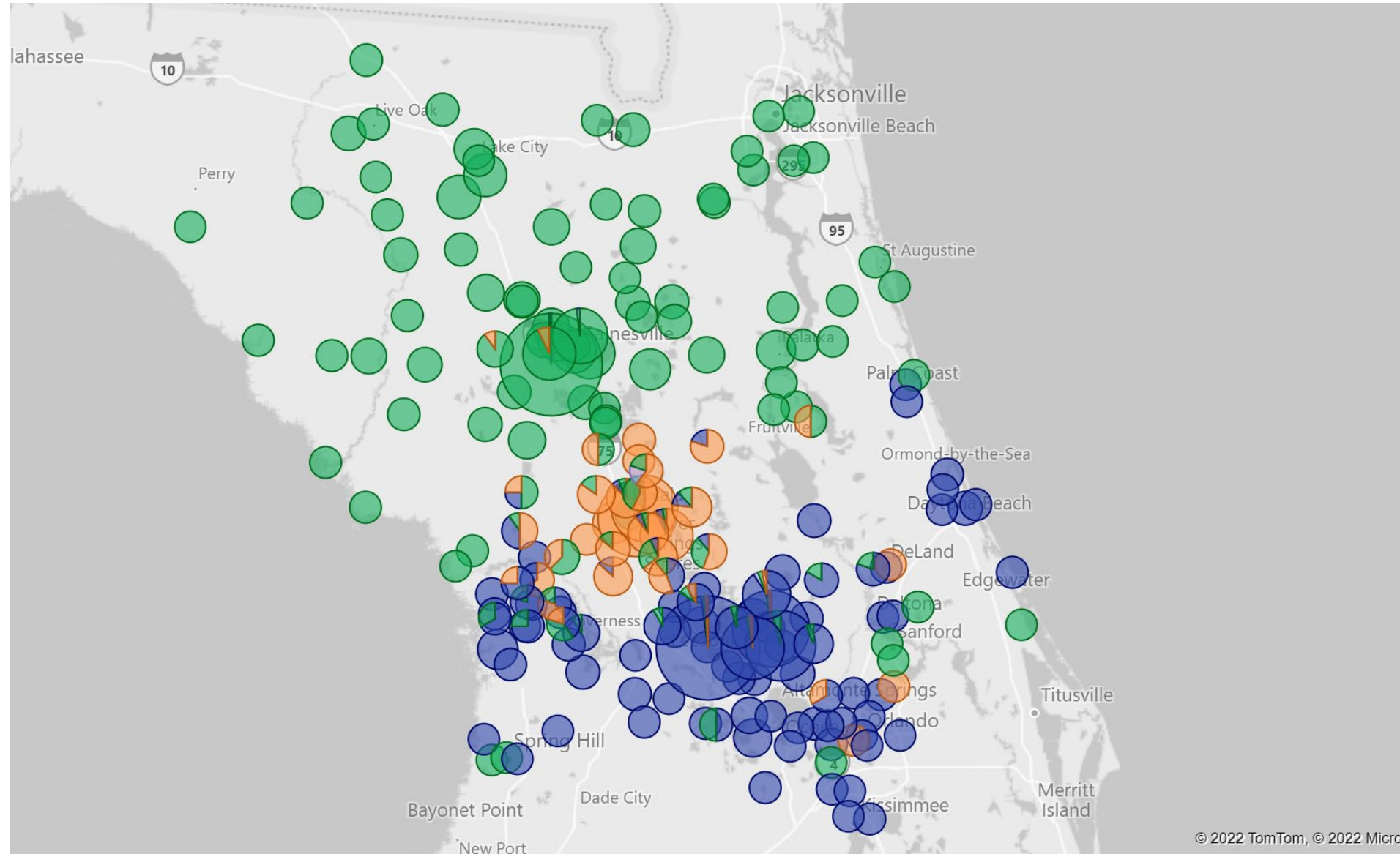
# Current Locations

- Langley Federally Qualified Health Center
  - 2 locations- Ocala and Sumter
- Wellness Integration Clinics (WIN) with LifeStream
  - 2 locations- Eustis and Leesburg
- South Lake Hospital Emergency Department
- The Health Department of Marion County
  
- Next Steps:
  - Integrate into High School Locations
  - Work in collaboration with the Guidance staff to screen students and provide appropriate interventions and referral as needed.

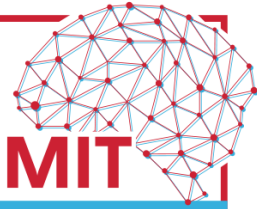
When John Pracko arrived at substance use treatment campus Beacon Point in September for alcohol detoxification, he was “a mess,” he said.

“I drank every day, like I would drink till I couldn't function basically because I didn't want to deal with anything,” he said. “But with the help of Beacon Point and all of the support and stuff they've given me, I have another opportunity in life right now.”

Pracko is one of many Marion County individuals who have benefited from LSF Health Systems' SETS (Screen, Engage, and Treat for Success) program, where peer specialists, who are in recovery themselves, serve people with substance use disorders.







Like Pracko, Vanessa Autry feels the program has given her another chance after a cocaine overdose in May.

“It was life-changing. Before, I felt like I was always in pain,” she said, adding that no one understood what she was going through. “I felt like I’m broken and lost. I had no hope, anything like that. I got a second chance to redeem myself.”





# Key Take Aways

- Be Responsive to Community Needs
- Harm Reduction
- Meet Clients in their space and work with their internal motivation
- Couple traditional recovery options with nontraditional programs and community supports
- Embrace Technology
- Use Data
  - Follow data trends and identify undeserved locations and populations
  - Imbed services in the locations where clients are frequenting.
