Needs Assessment: What, Why, How, So What?

- **394.9082 F.S. Managing entities shall:**
Conduct a community behavioral health care needs assessment every 3 years in the geographic area served by the managing entity which identifies needs by subregion. The process for conducting the needs assessment shall include an opportunity for public participation.
- LSF Health Systems (LSFHS) considers assessment of need an ongoing process - active presence in community meetings and events provides real time information on system needs. Formal assessments were conducted by WellFlorida Council and M.T.M. Services and included gathering and analysis of quantitative and qualitative data as well as surveys and focus groups for individuals served, stakeholders and providers.

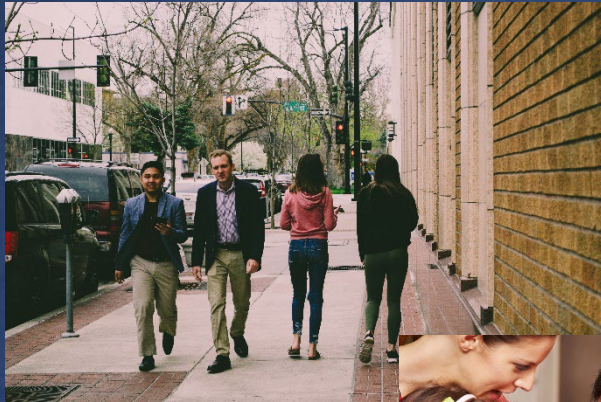
Needs Assessment: What, Why, How, So What?

- This assessment will serve to inform the development of the LSFHS Strategic Plan, the annual enhancement plans submitted to the Department of Children and Families to address unmet needs, and ongoing decisions regarding funding and programmatic investments.
- LSFHS will use this assessment as a call to action, engaging providers, consumers, stakeholders and community members, in creating effective programs and policies and collaborating with other organizations to bring positive change to our communities.

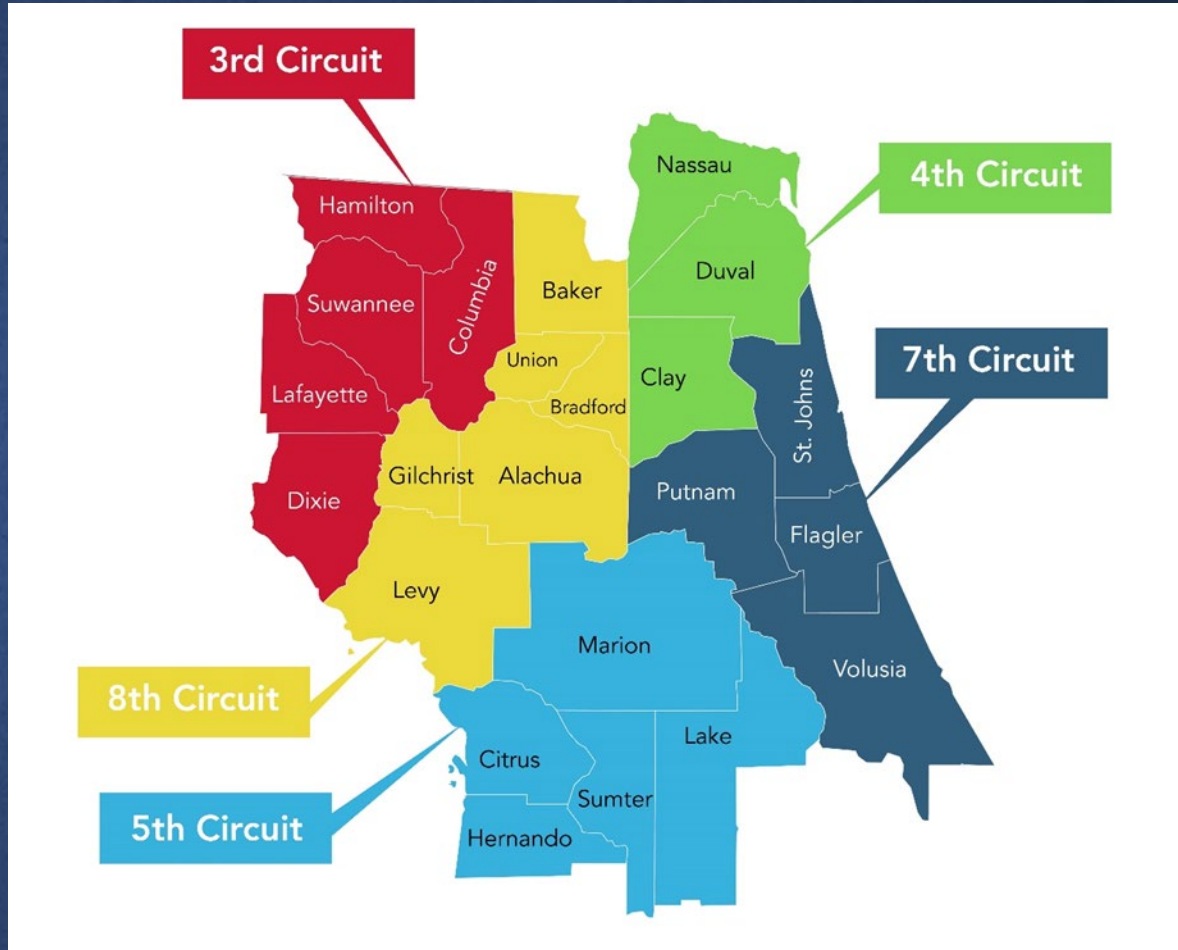
Methodology



Generally, the health of a community is measured by the physical, mental, environmental and social well-being of its residents. Due to the complex determinants of health, the Behavioral Health Needs Assessment is driven by both quantitative and qualitative data collecting and analysis from both primary and secondary data sources.

- **Social determinants of health** including socioeconomic demographics, poverty rates, population demographics, uninsured population estimates and educational attainment levels
- **Community Health status** including County Health Rankings, CDC's Behavioral Risk Factor Surveillance Survey, and hospital utilization data
- **Health system assessment** including insurance coverage (public and private), Medicaid eligibility, health care expenditures by payor source, hospital utilization data, physician supply rate and health professional shortage areas
- **Community input** including surveys of consumers, providers and stakeholders as well as focus groups in each Circuit. The data collected through these processes as well as LSFHS service utilization data were analyzed for trends and community priorities

Top Five Needs Identified in 2019 Needs Assessment

1. Short Term Residential Treatment Beds
2. Substance Abuse Detox, Residential Treatment Beds and Outpatient SA treatment
3. Care Coordination and Housing Vouchers to stabilize and support individuals in the community
4. Co-Responder Teams to divert individuals from acute care and justice system
5. Workforce Investment to recruit and retain qualified staff in key positions

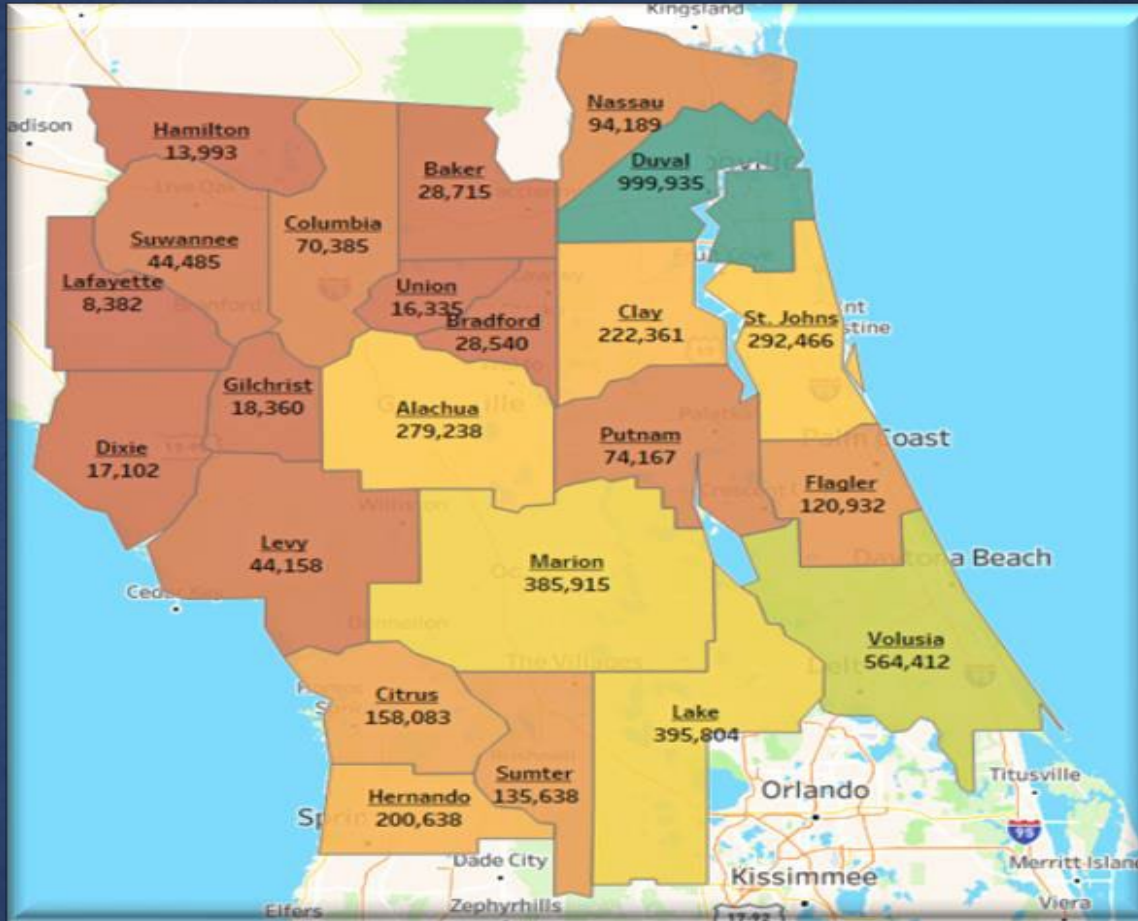

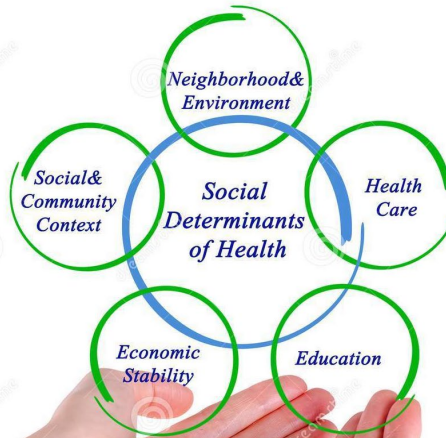

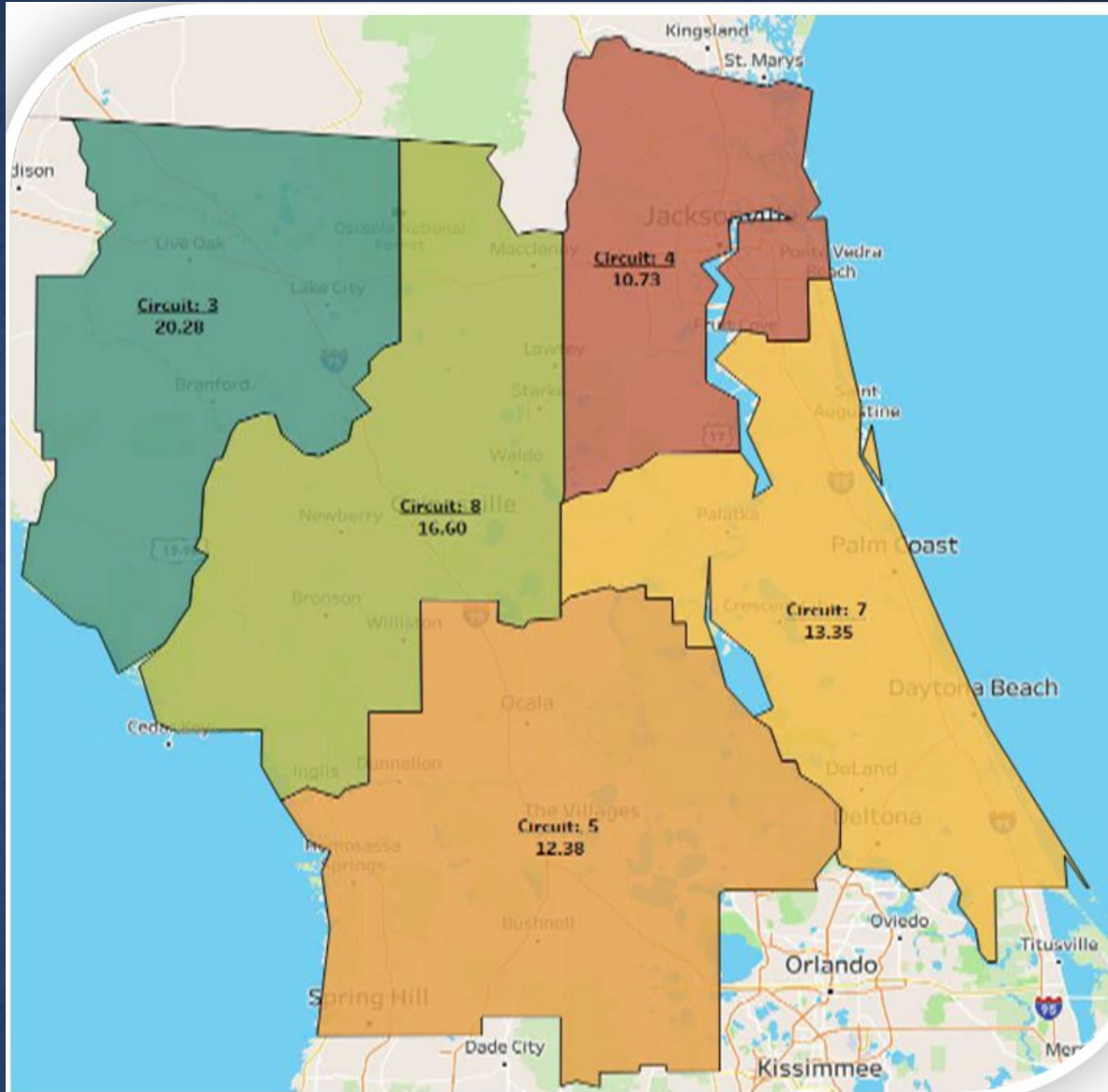

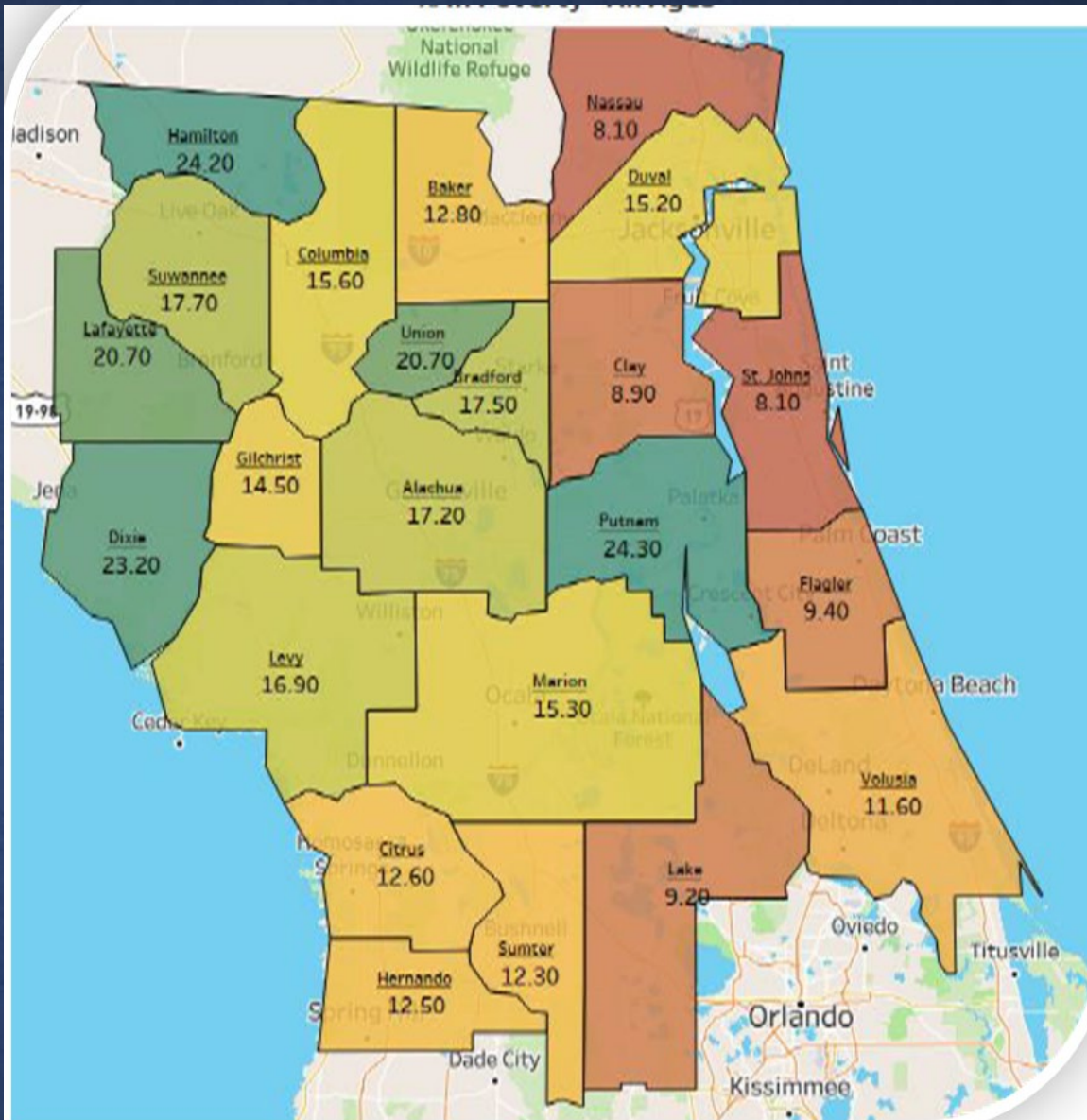

Percent in Poverty - All Ages - (Florida- 13.1%)

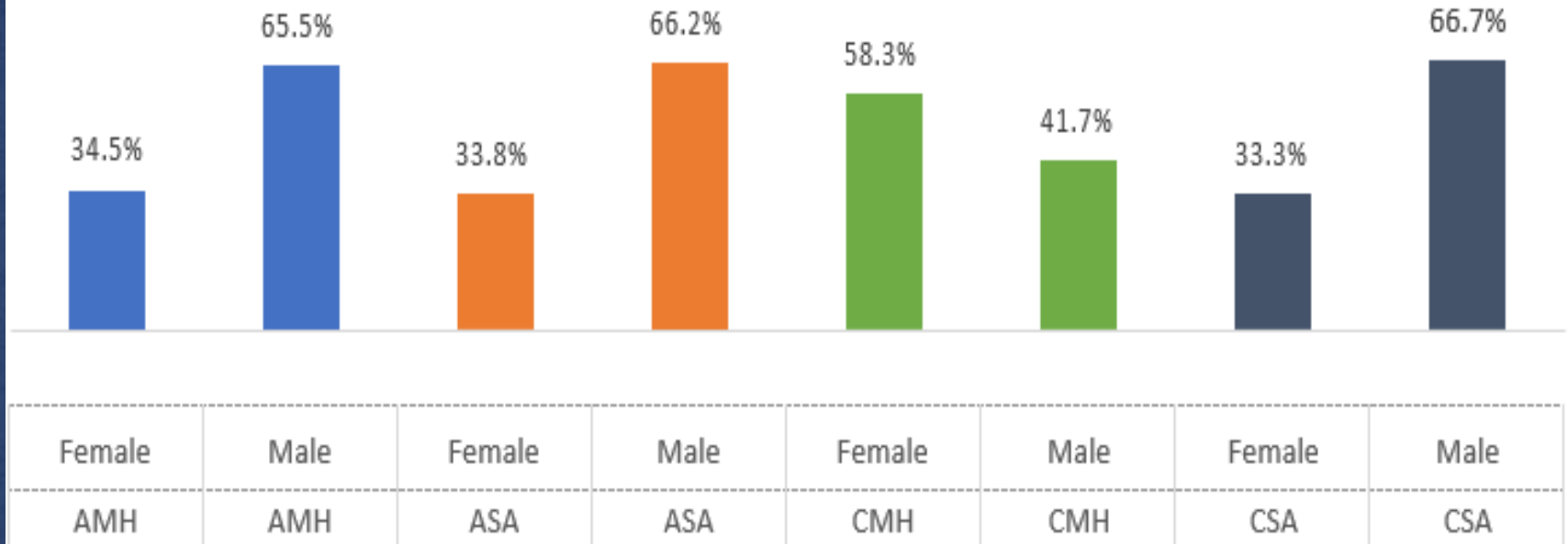

LSFHS Homelessness by Program and Gender

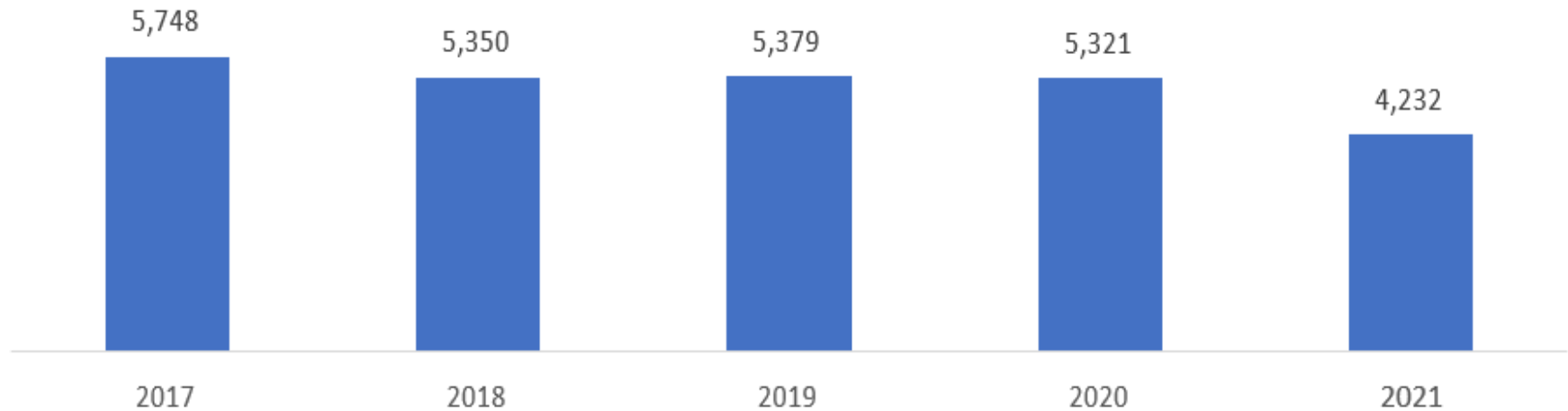


In FY 20/21, a total of 2,728 individuals served by LSFHS providers experienced homelessness, representing 5.5 percent of all those served by LSFHS.

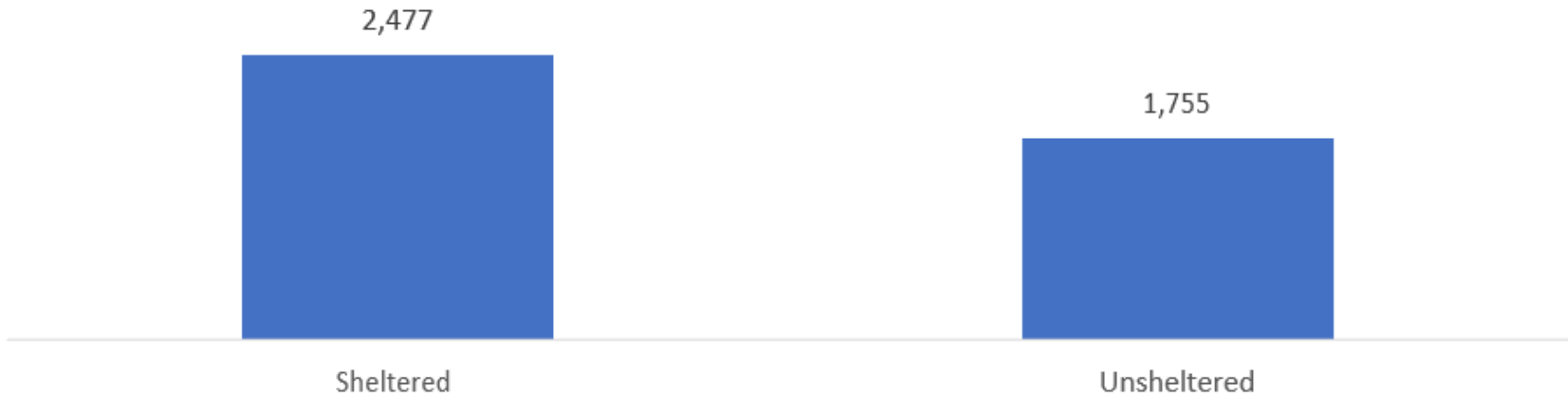
Total Homeless Population, District 3 and 4 (2017-2021)

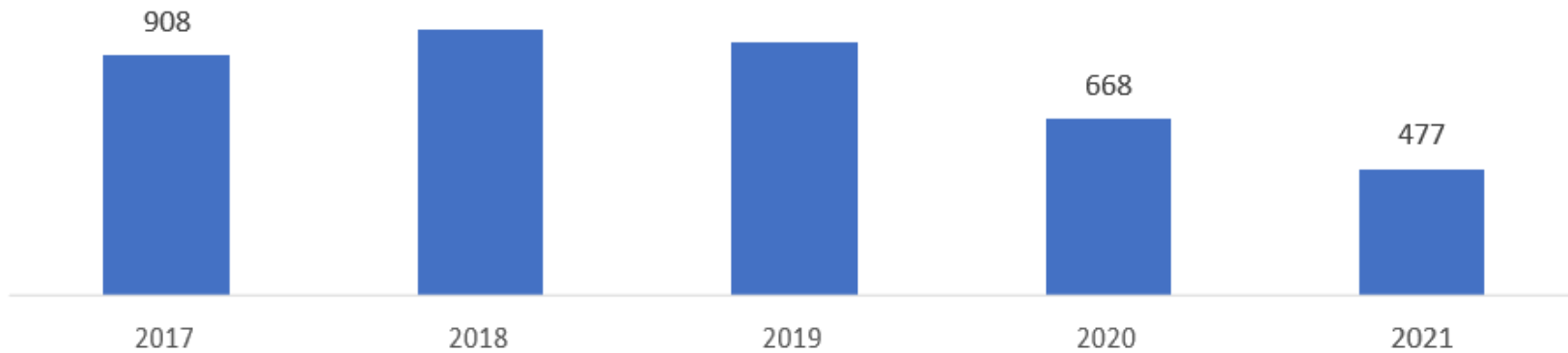
Total Homeless Population Sheltered and Unsheltered, District 3 and 4 (2021)

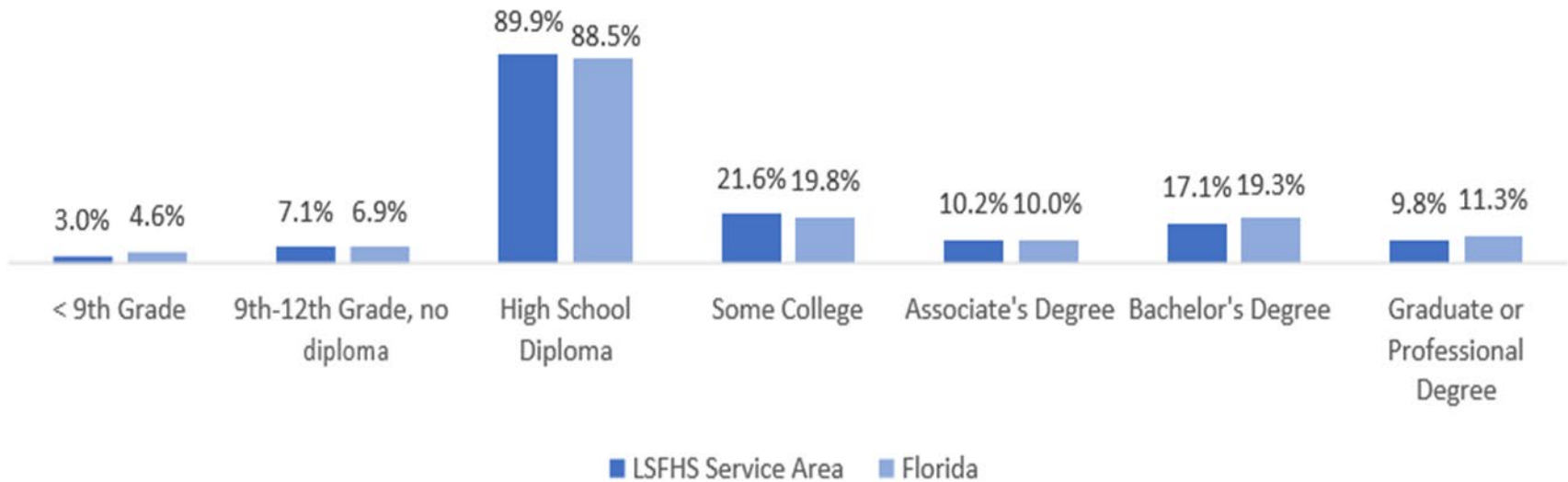

LSFHS Service Area Population by Educational Attainment, 2016-2020 (5-Year Estimate)



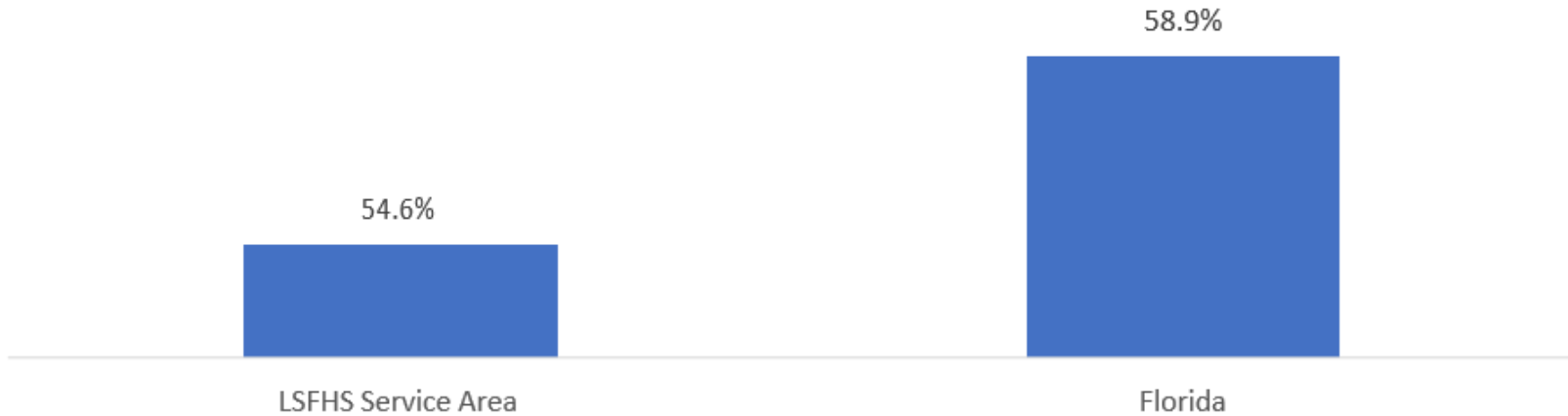

LSFHS Service Area Population Participation in Labor Force, 2016-2020 (5-Year Estimate)



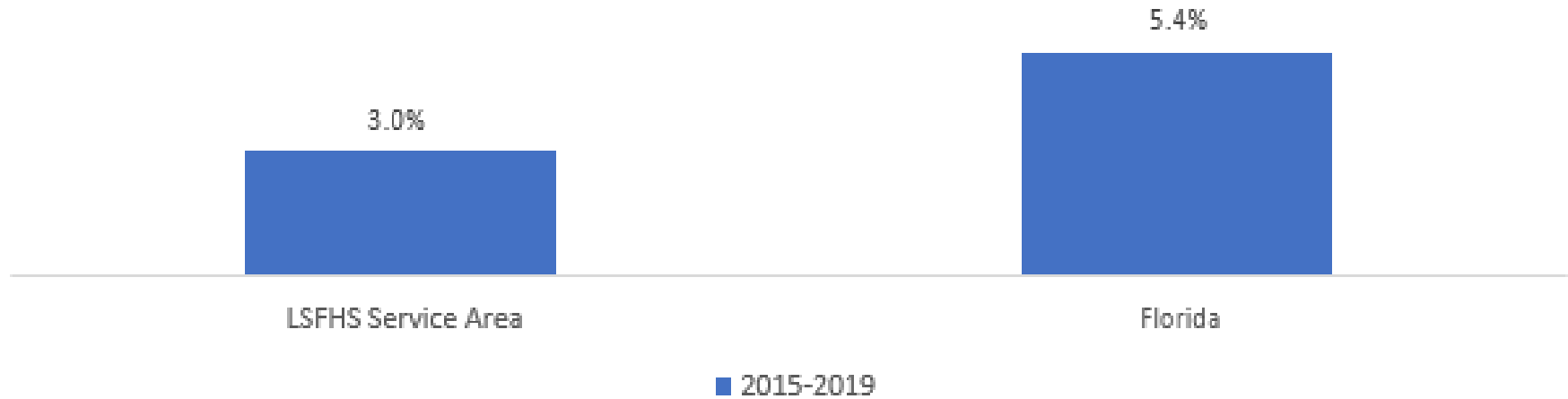

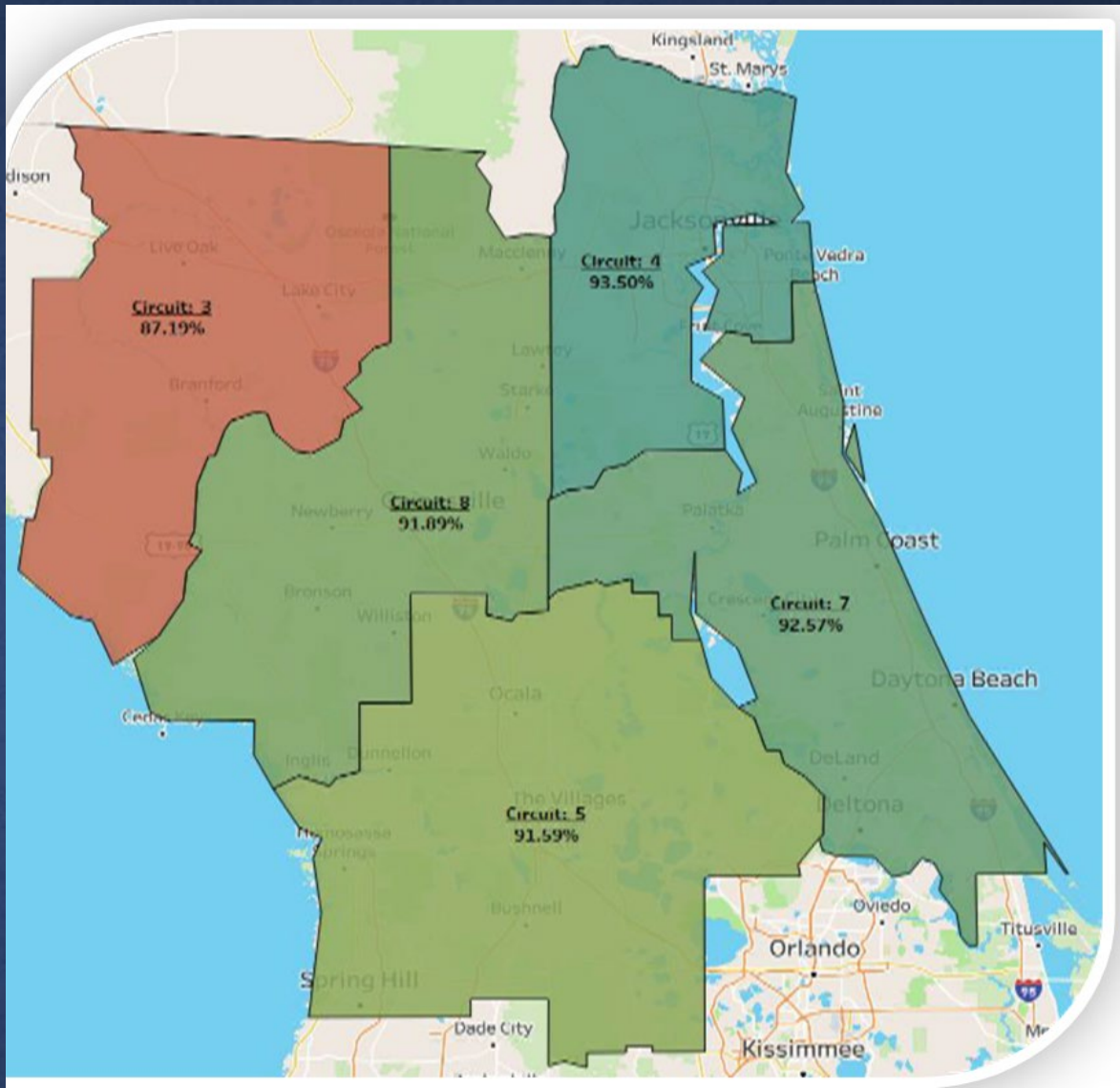

LSFHS Service Area Population Unemployment Rates, 2016-2020 (5-Year Estimate)



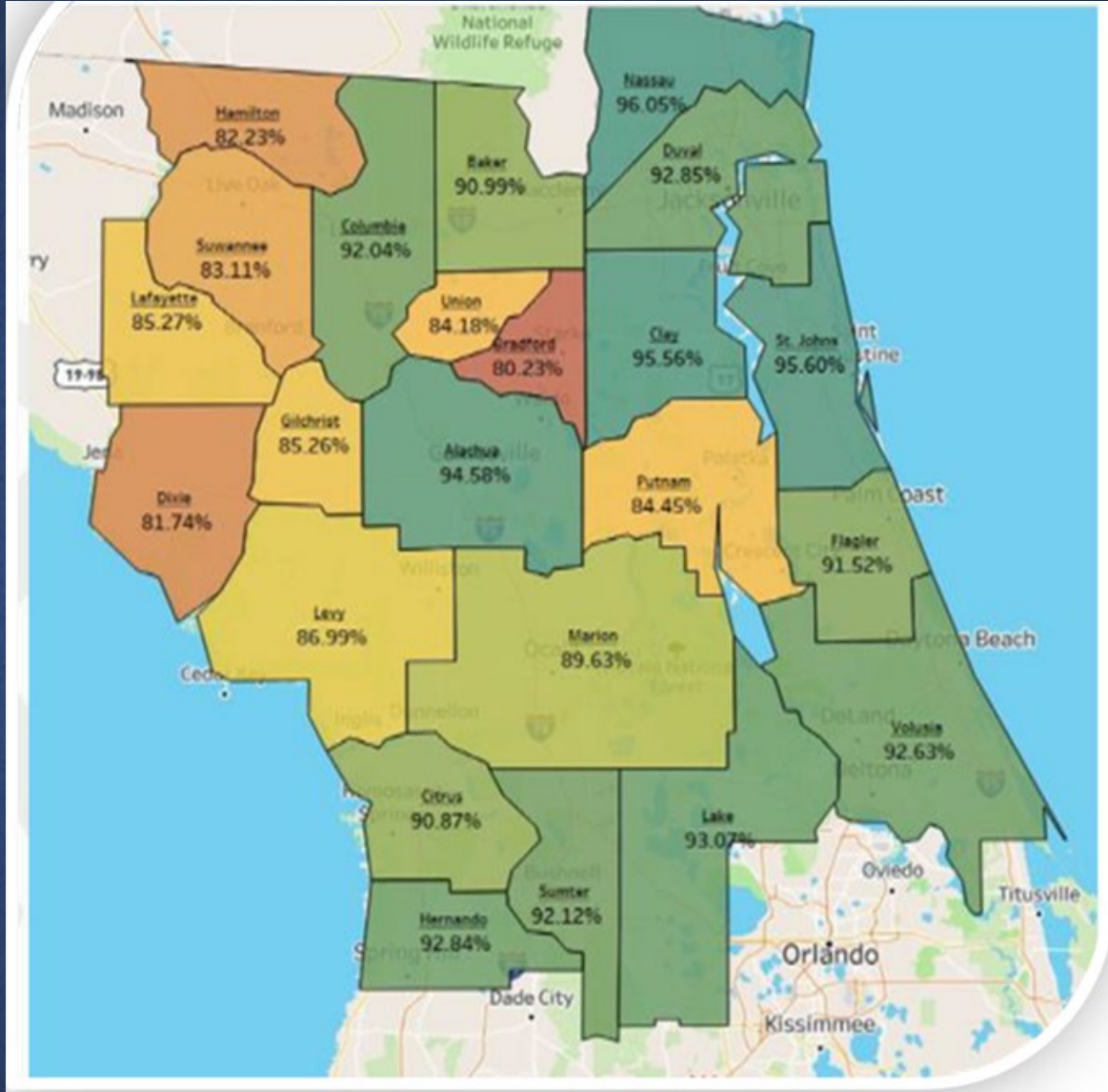

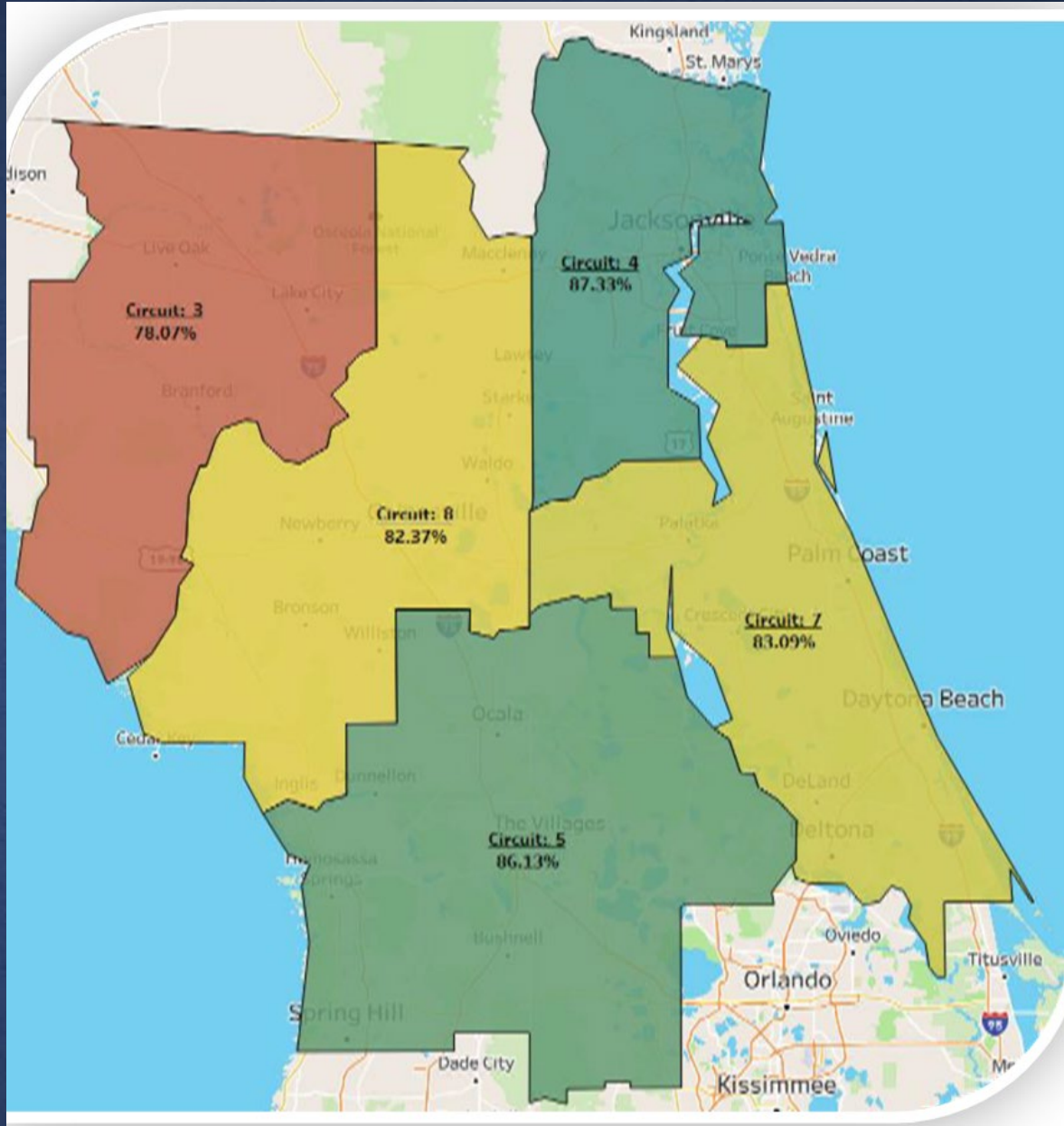

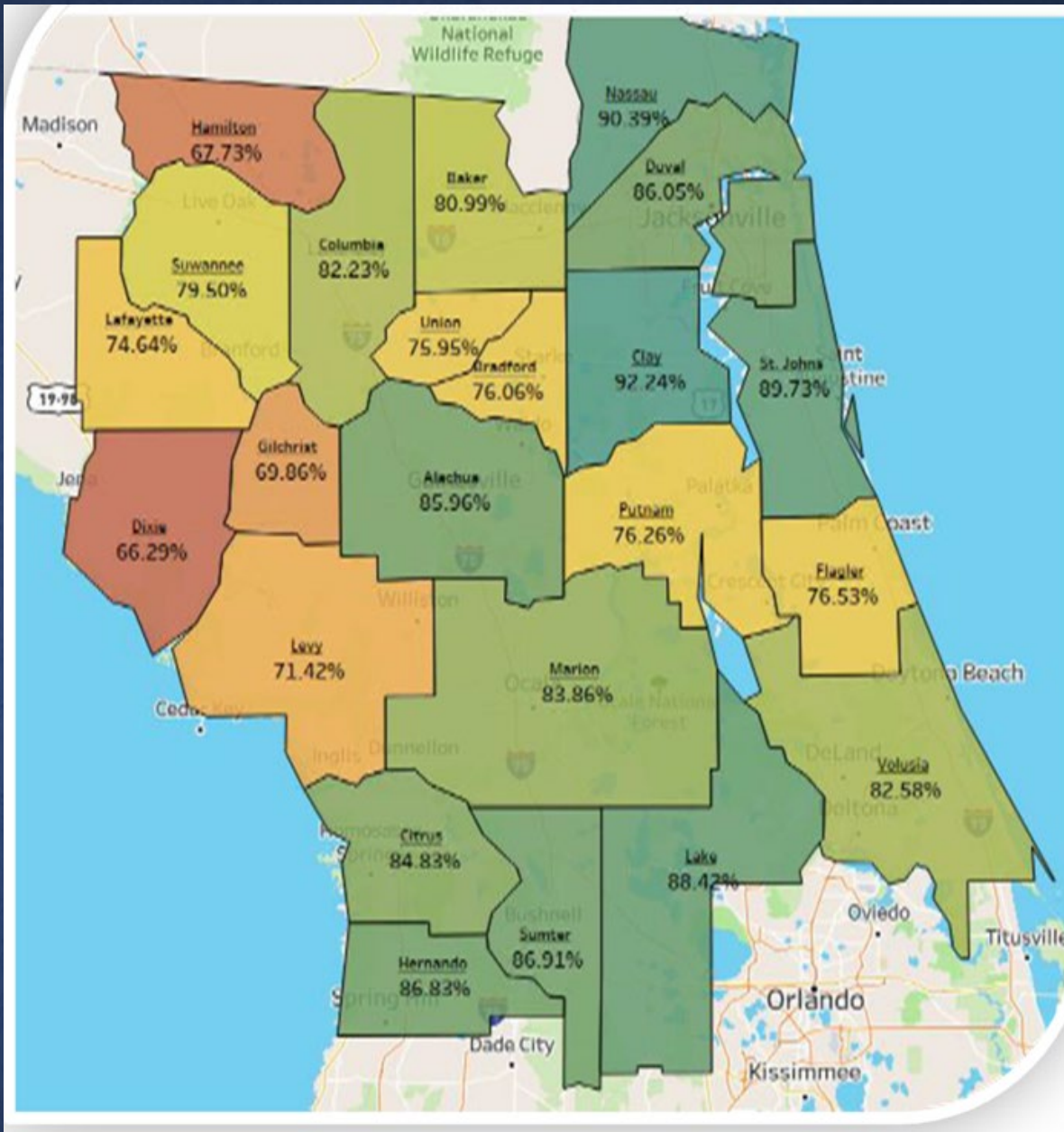

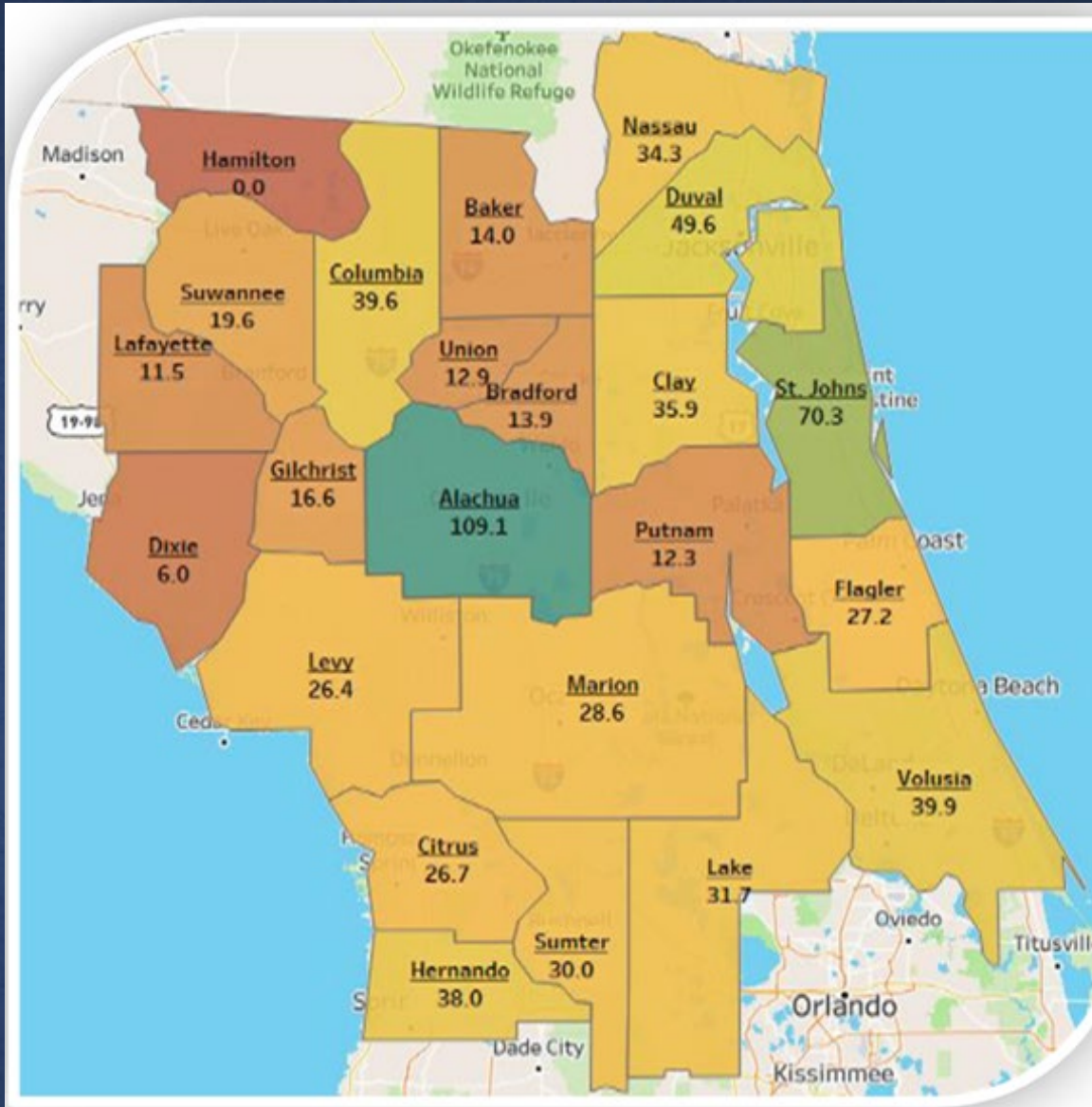

Mental Health Workforce Availability

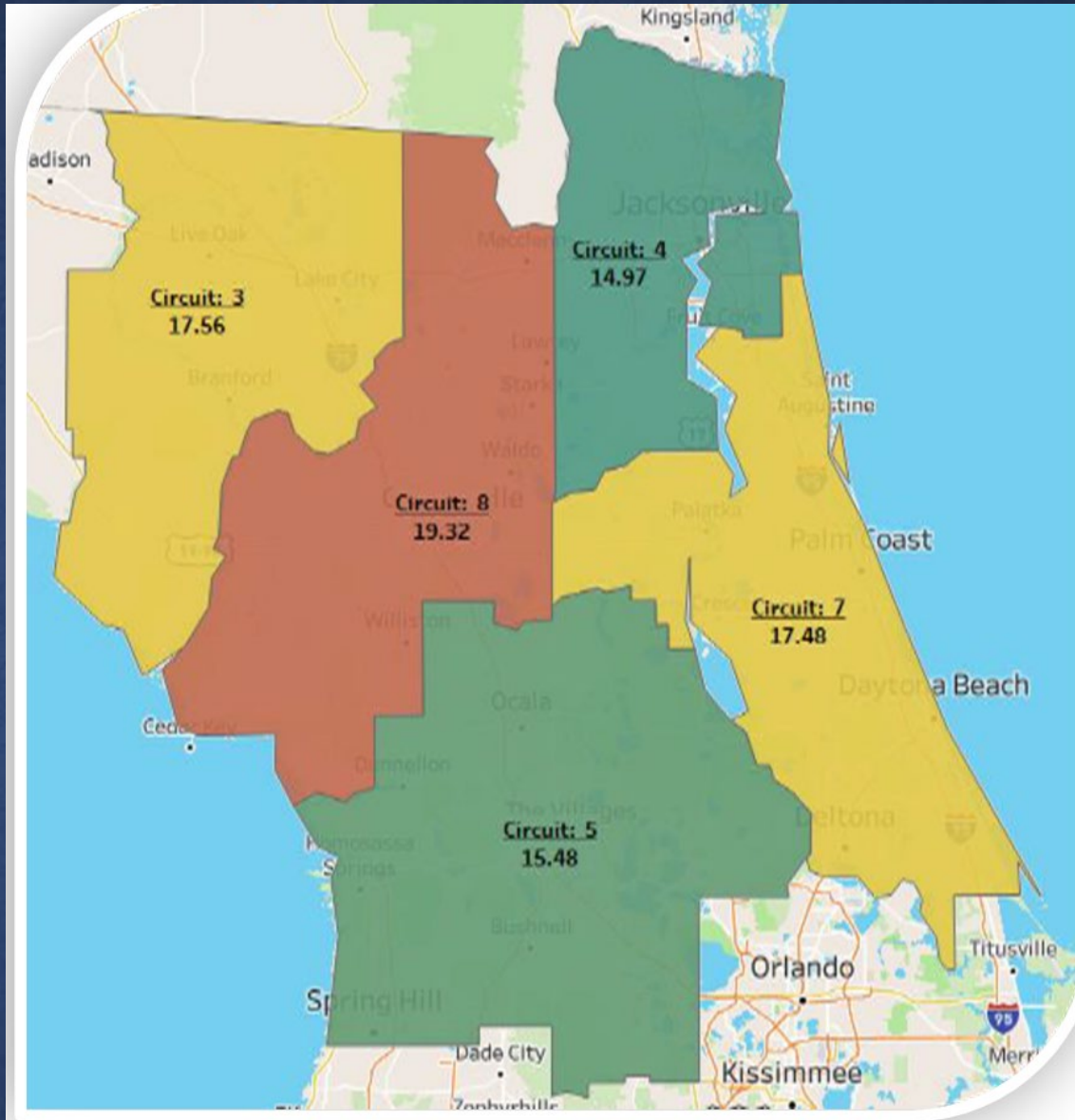

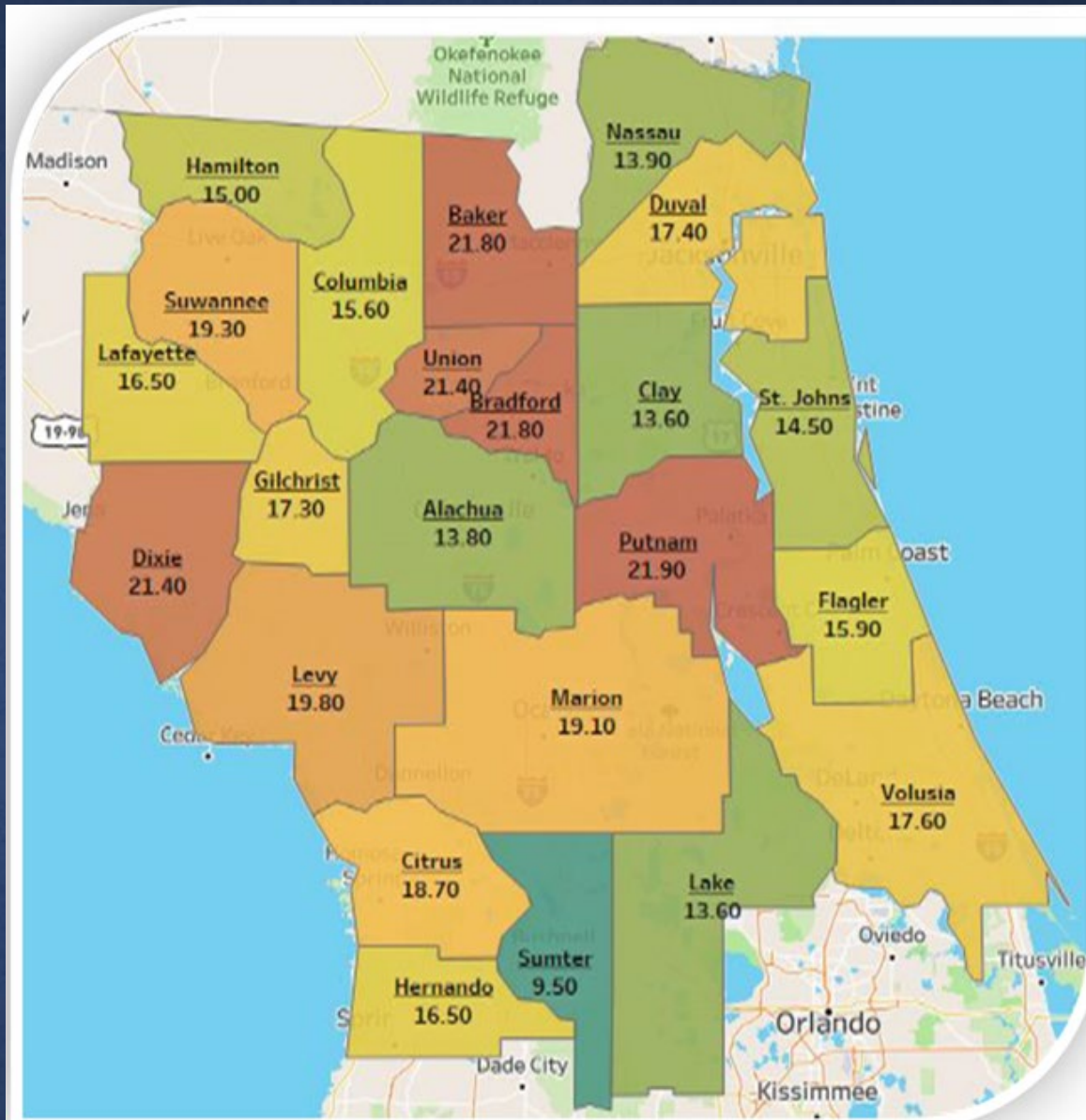

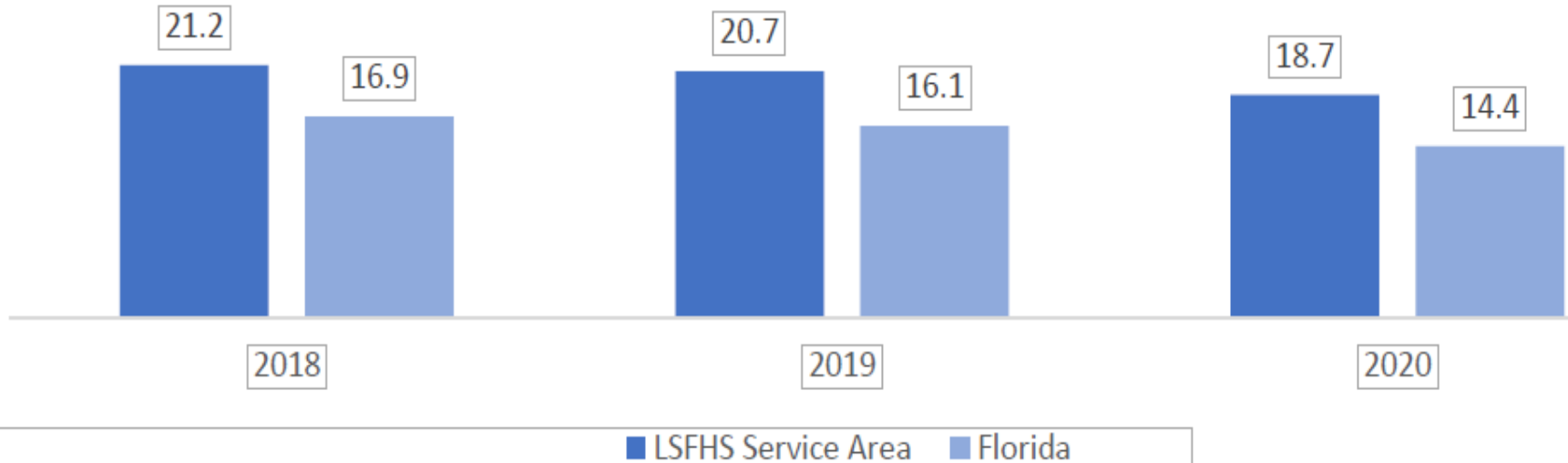

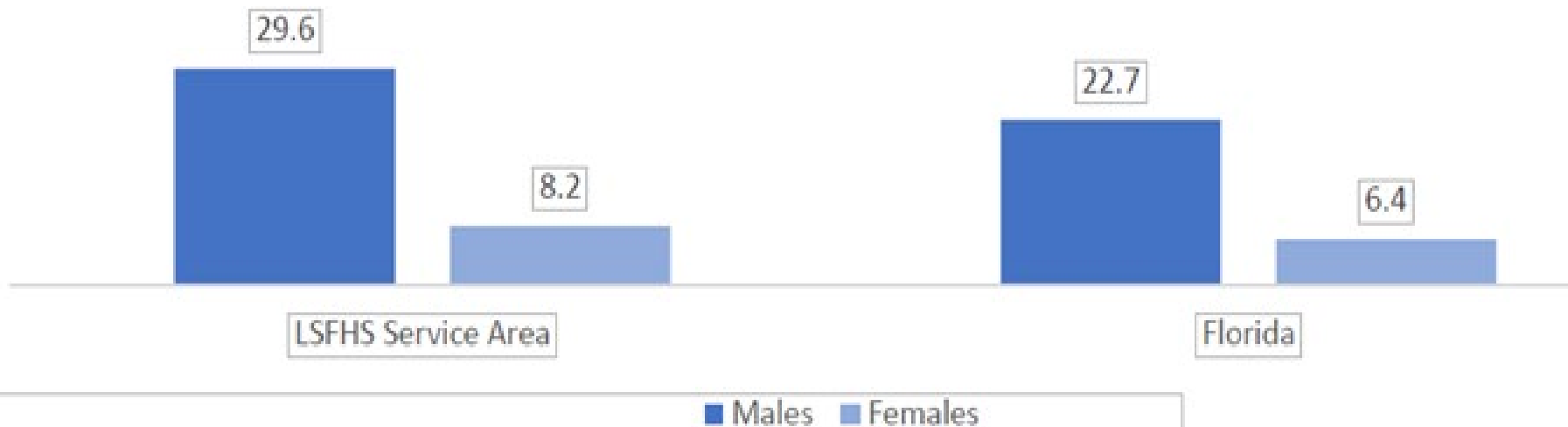
LSFHS Service Area Crude Suicide Death Rates (2018-2020)

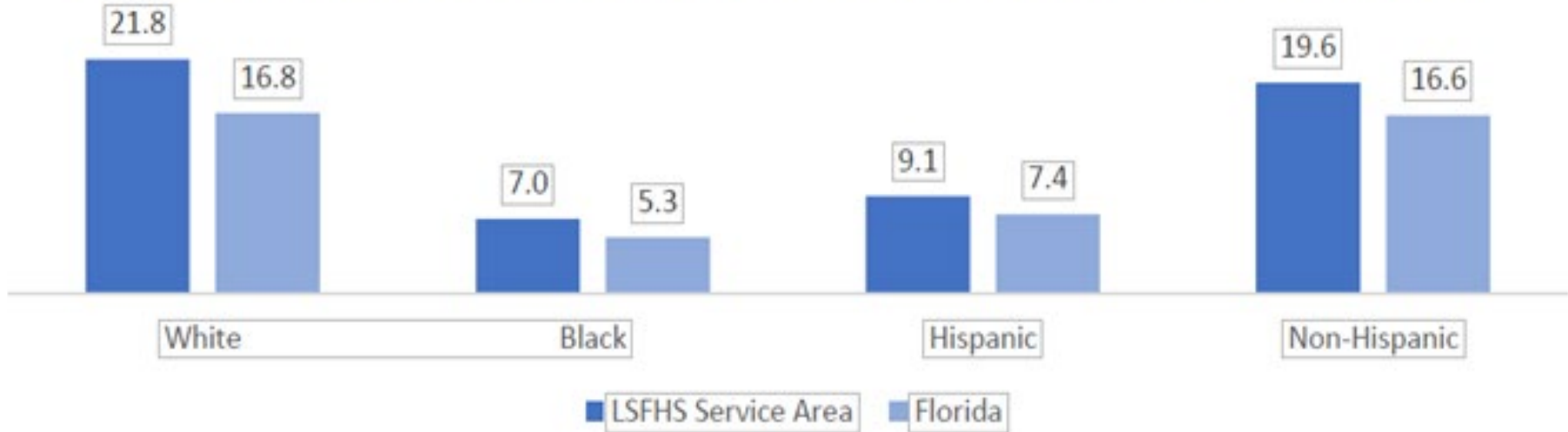
LSFHS Service Area Crude Suicide Death Rates by Gender (2020)



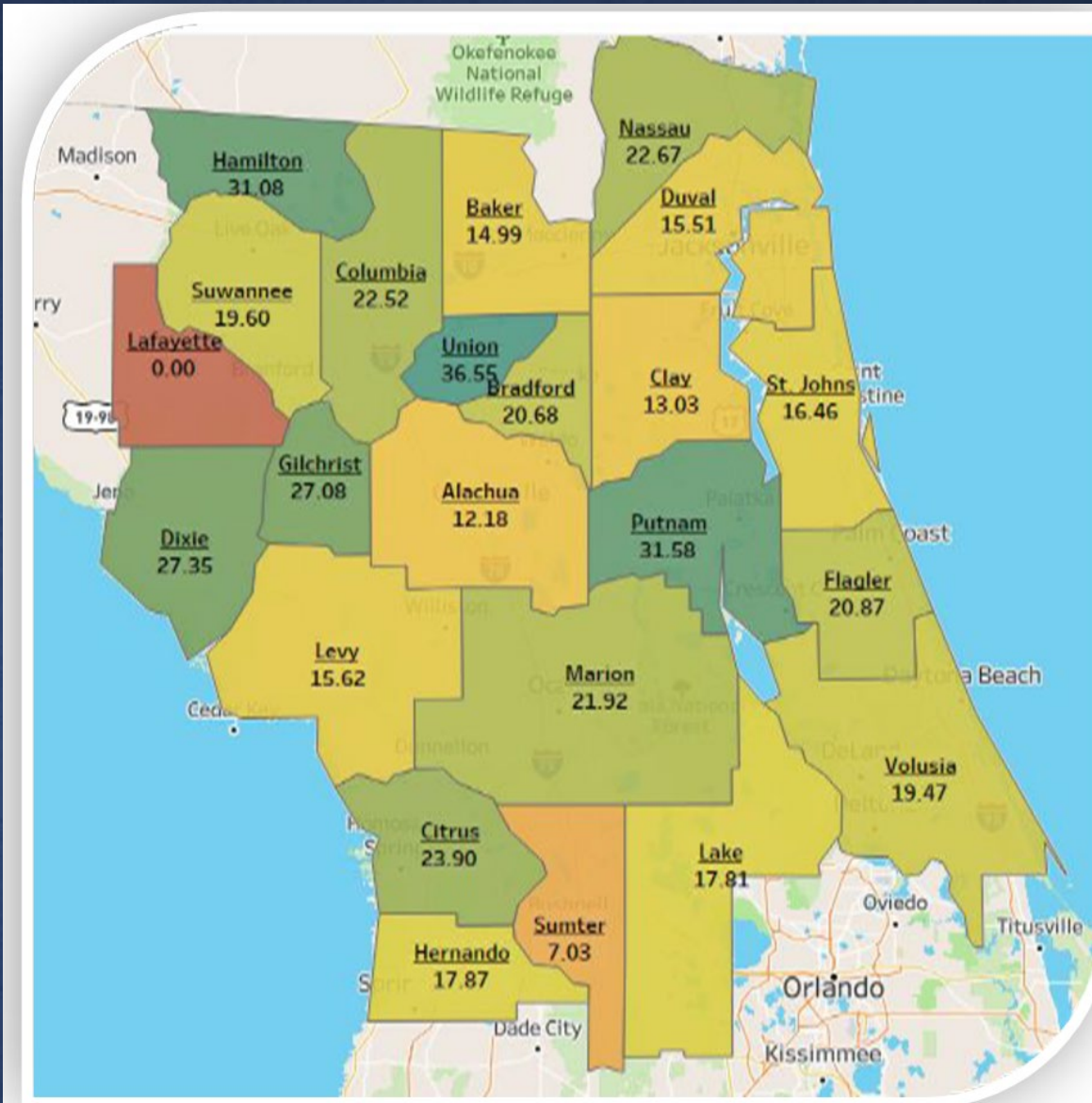

LSFHS Service Area Crude Suicide Death Rates by Race and Ethnicity (2020)

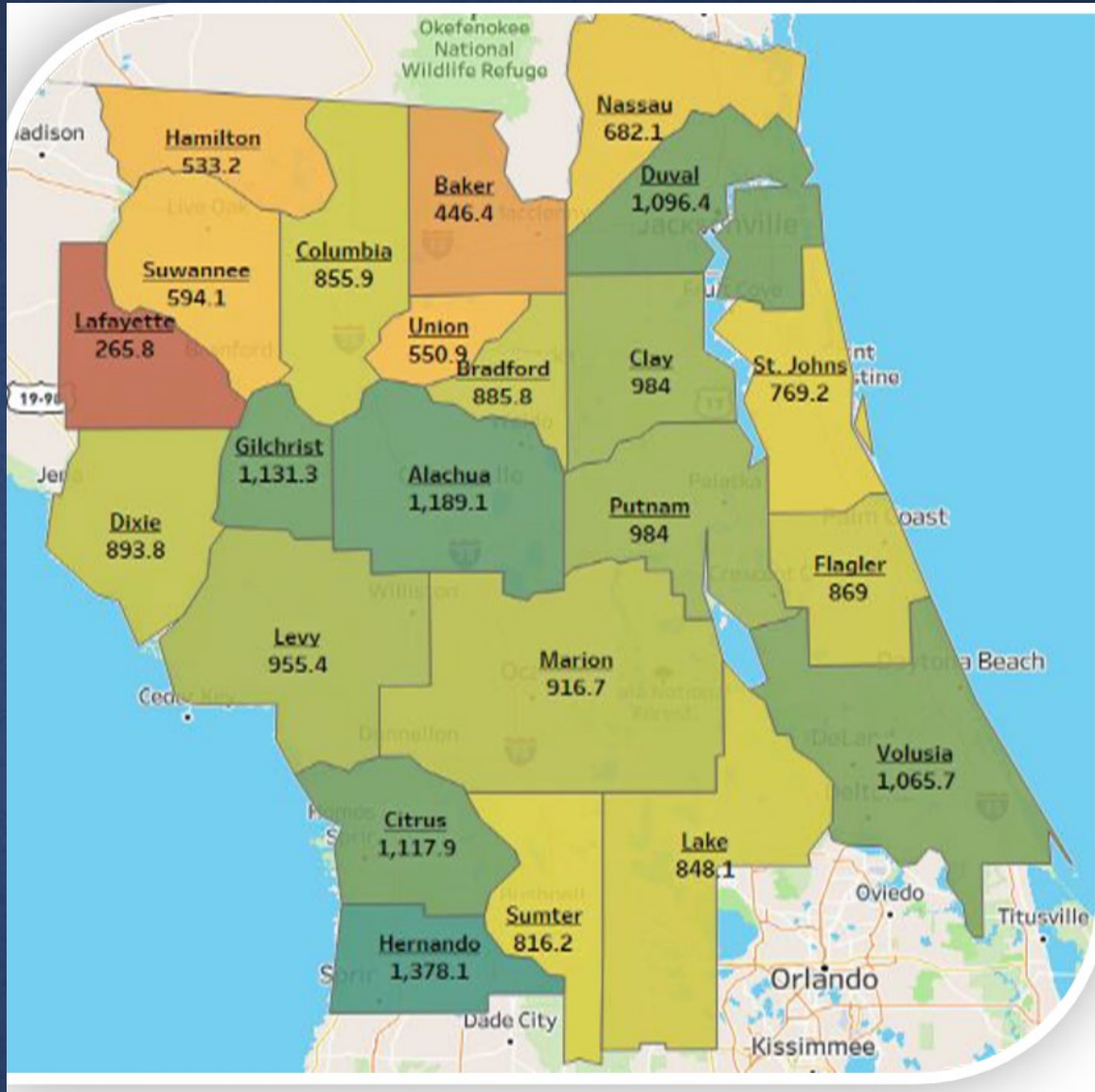

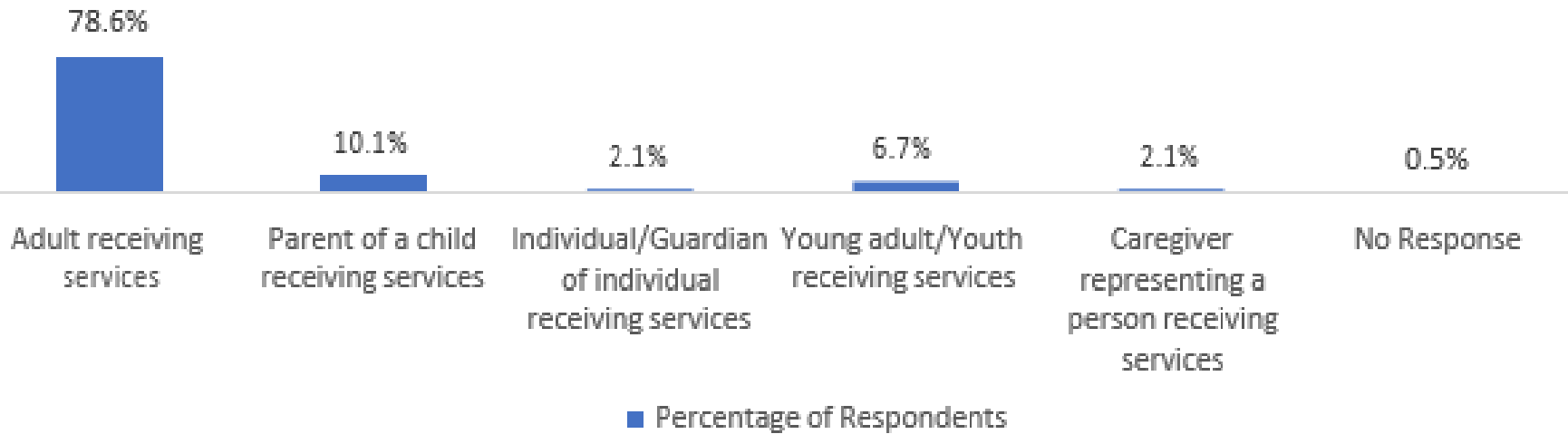

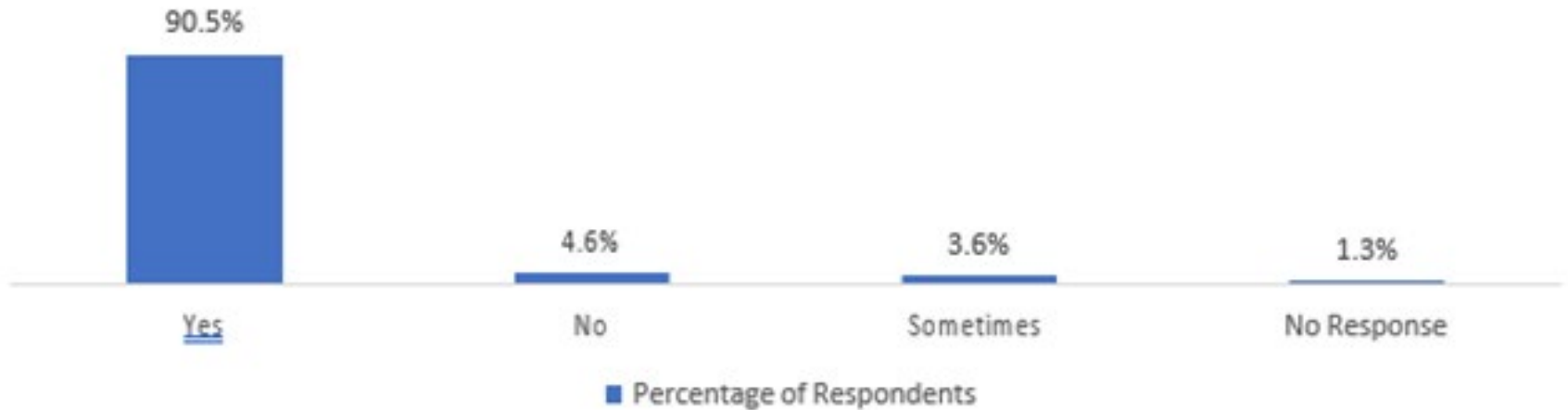

Did you know where to go for mental health and substance use treatment services when you needed them?

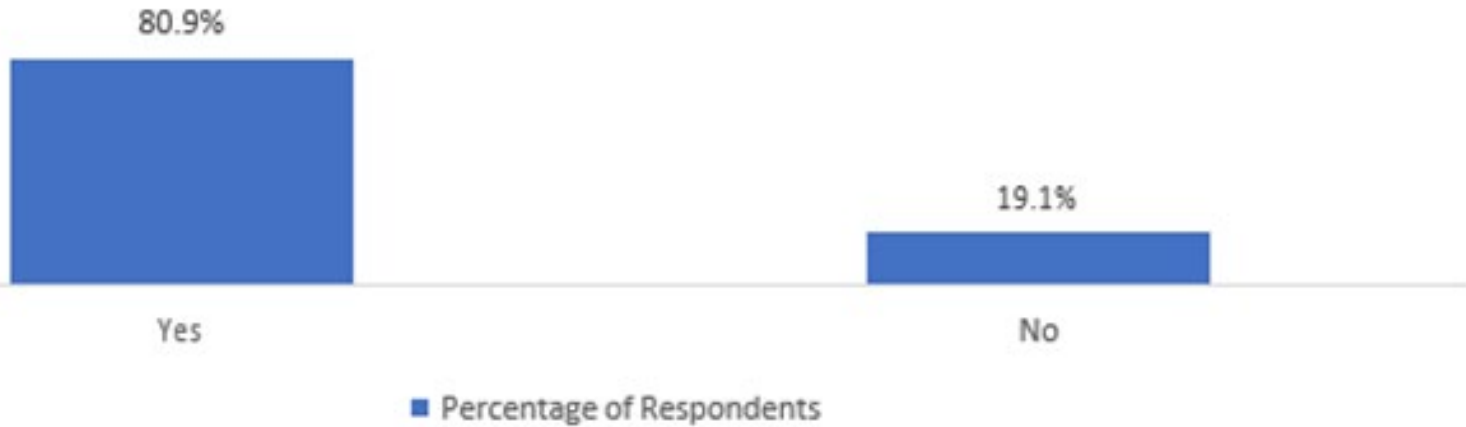

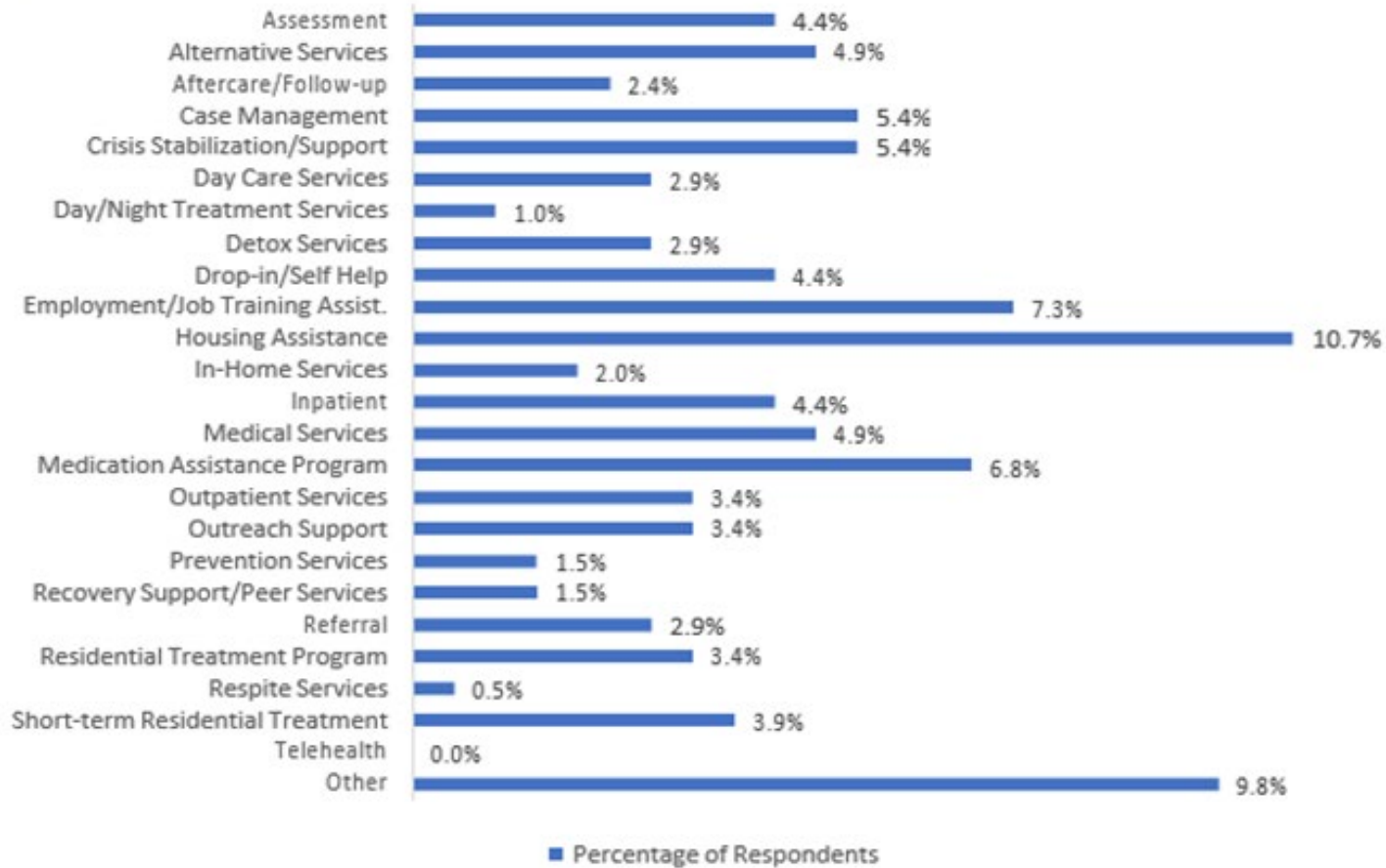


Were you able to get all the services you needed when you needed them?

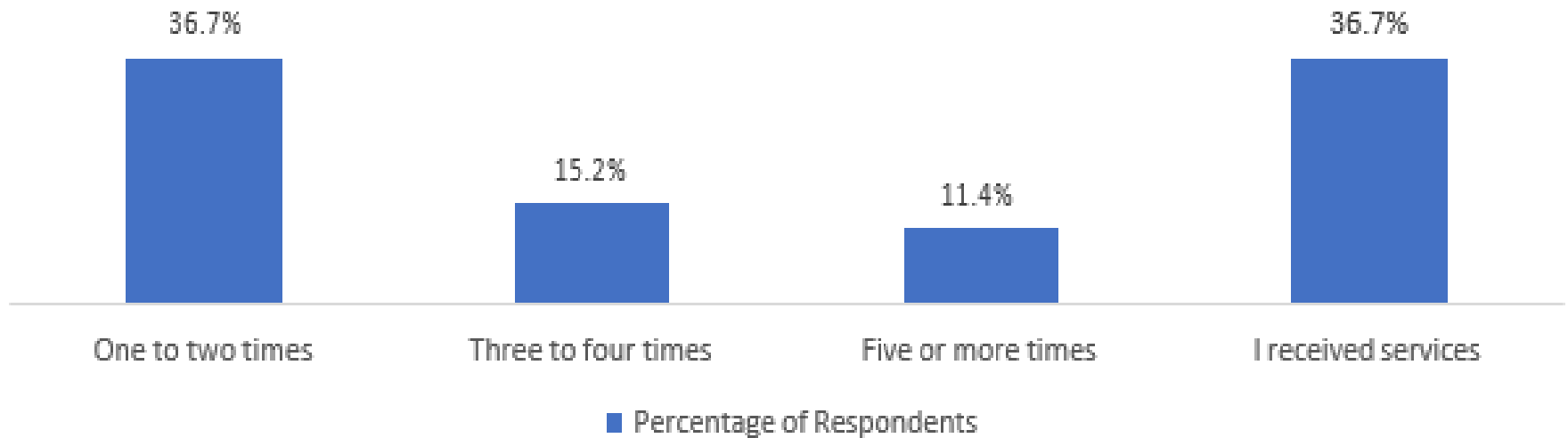

How many times during the last 12 months were you not able to get the services you needed?

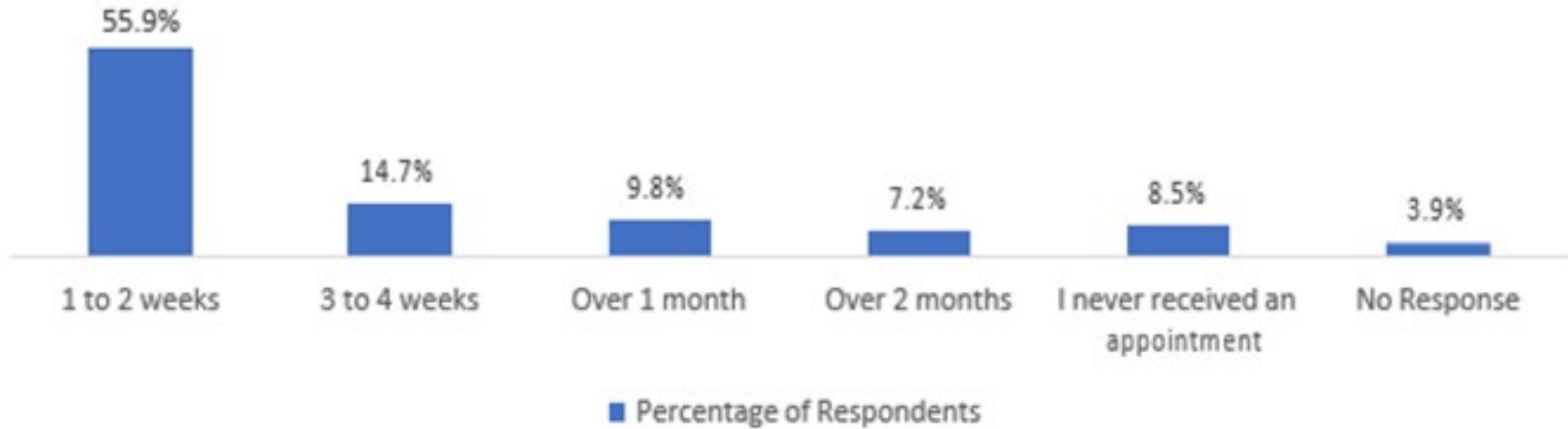

How long did it take from the time you requested an appointment for services to the time you received the services?

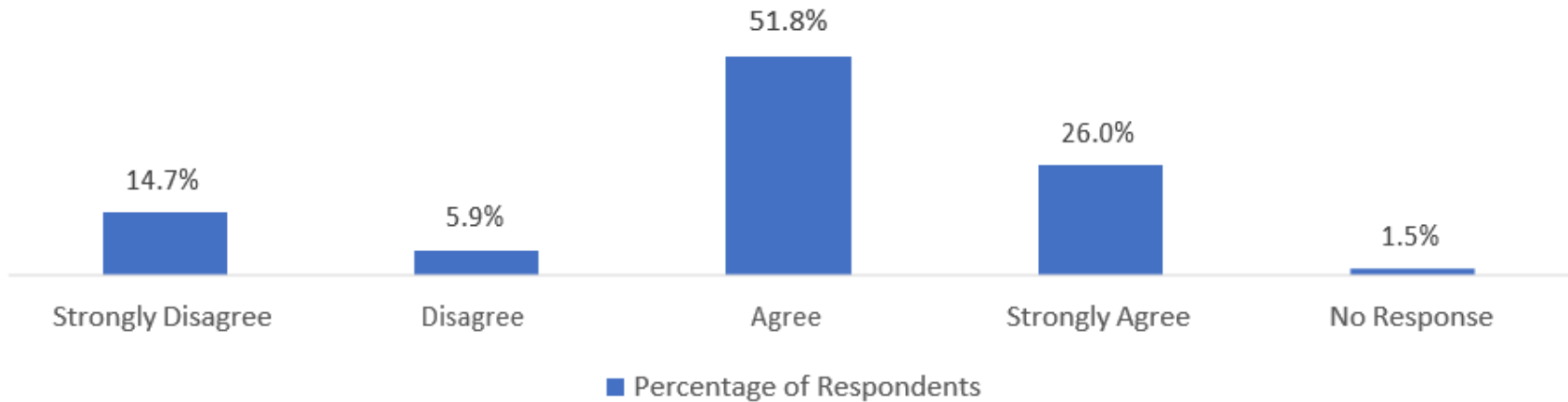

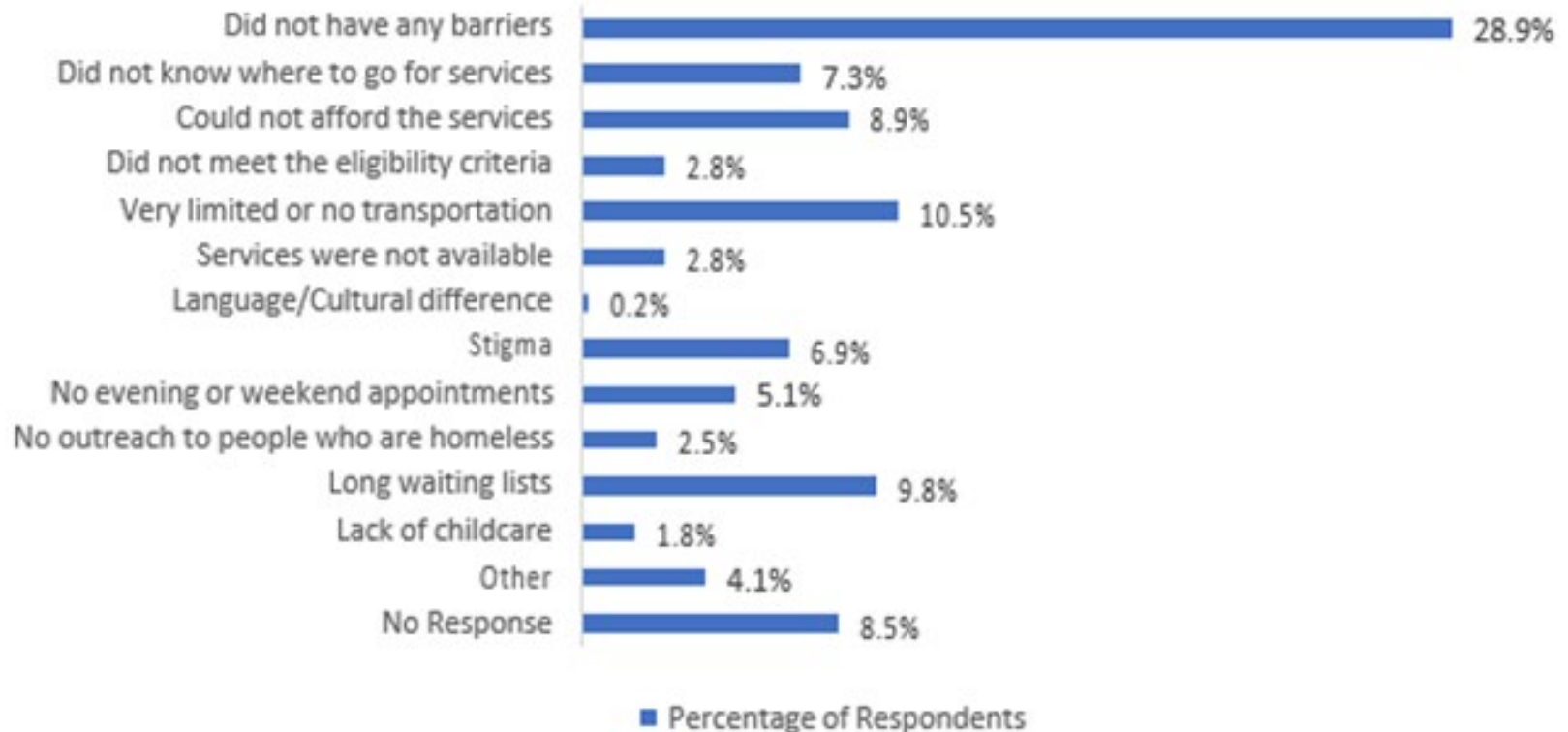


The services and planning I received were focused on my treatment needs (patient centered)

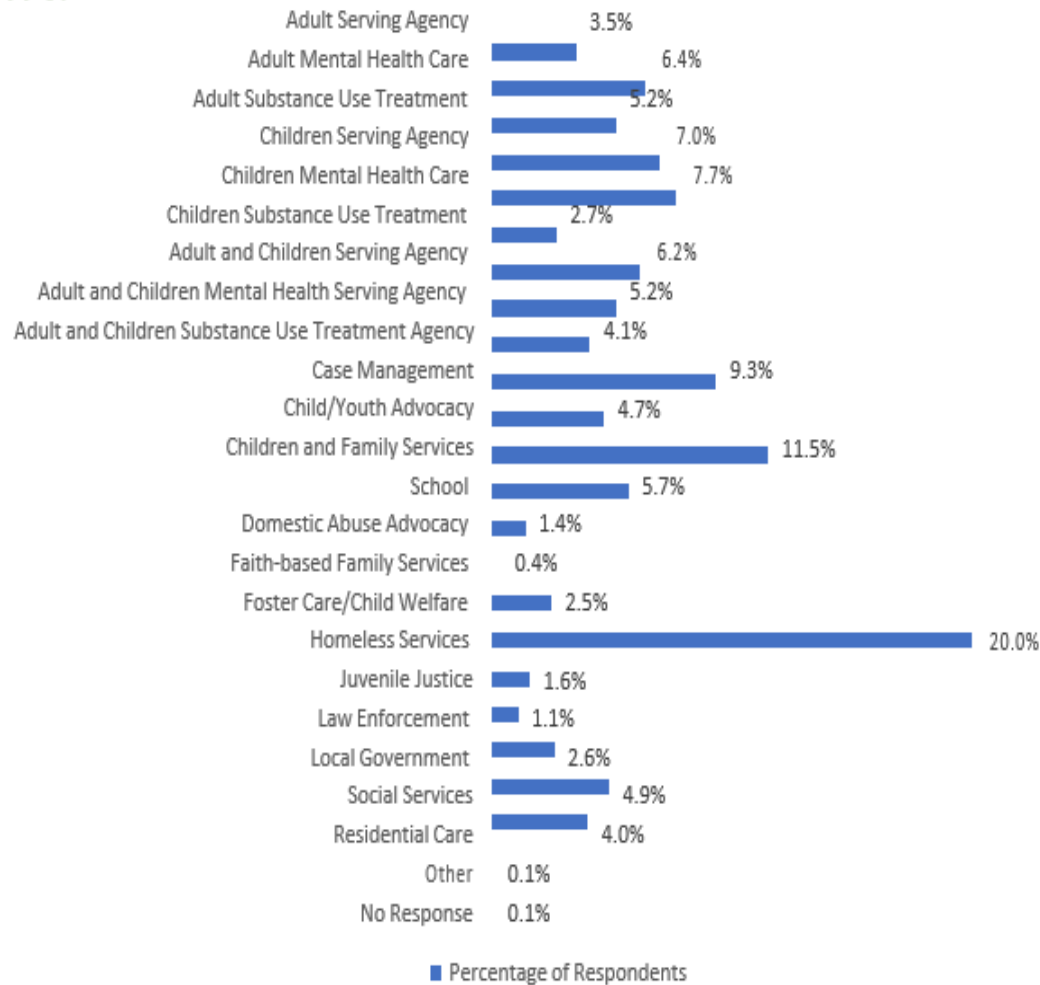

What were the obstacles you experienced getting the care you needed? (Check all that apply)

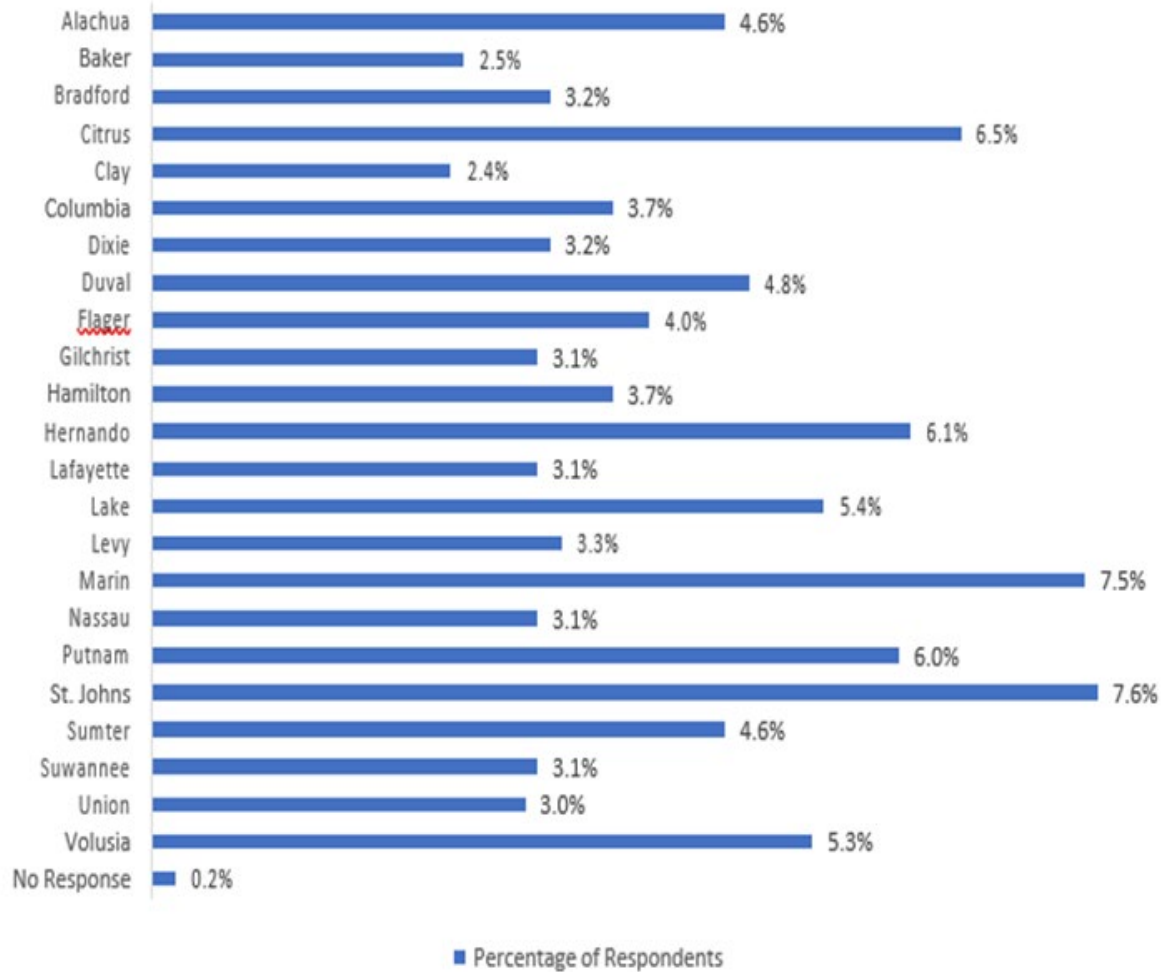

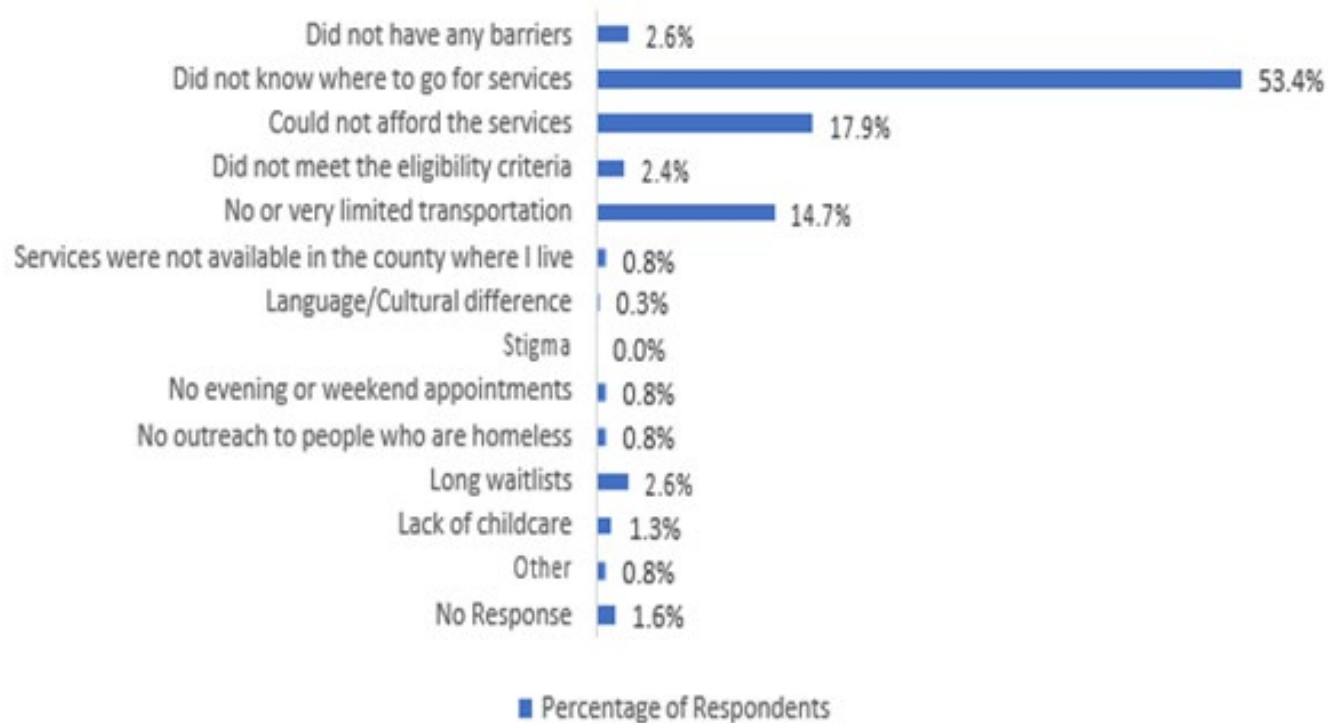

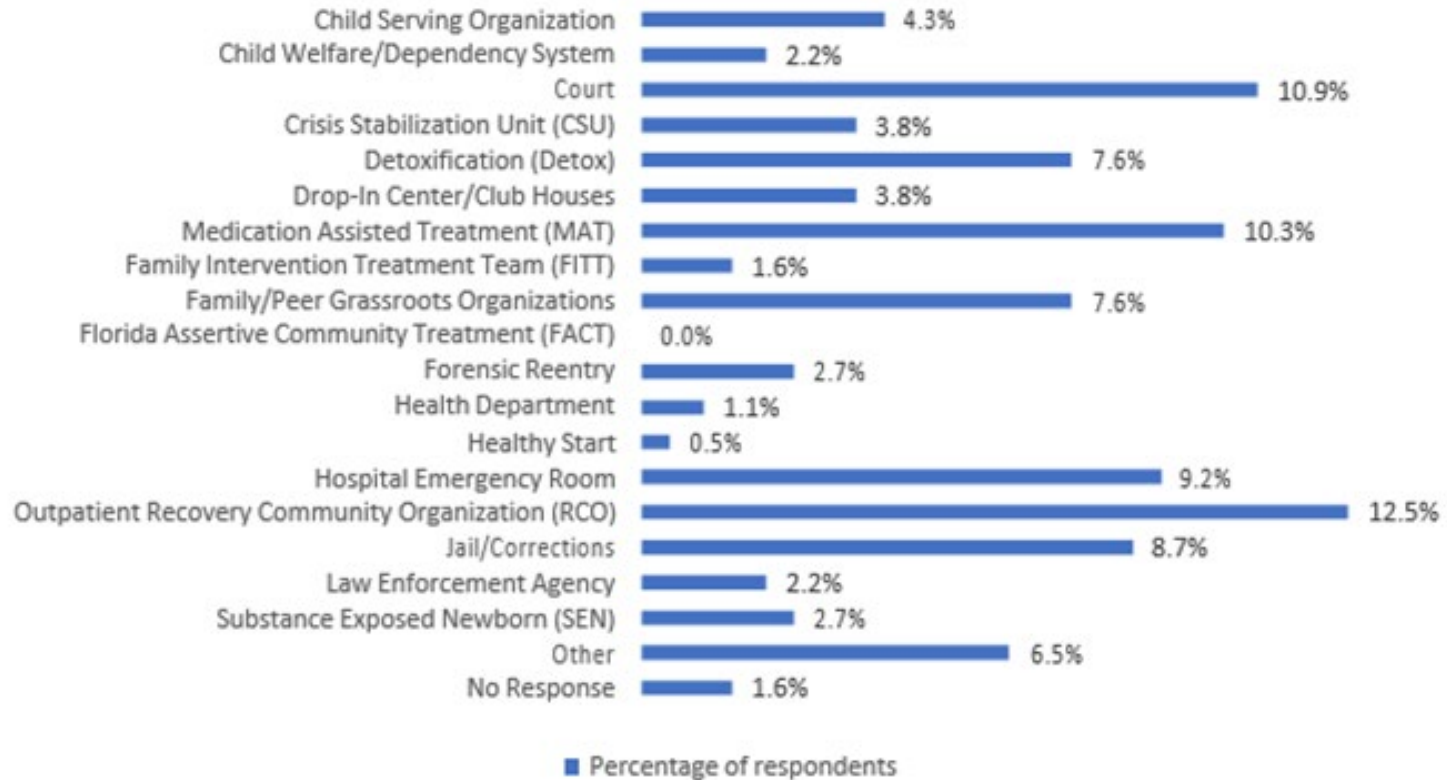

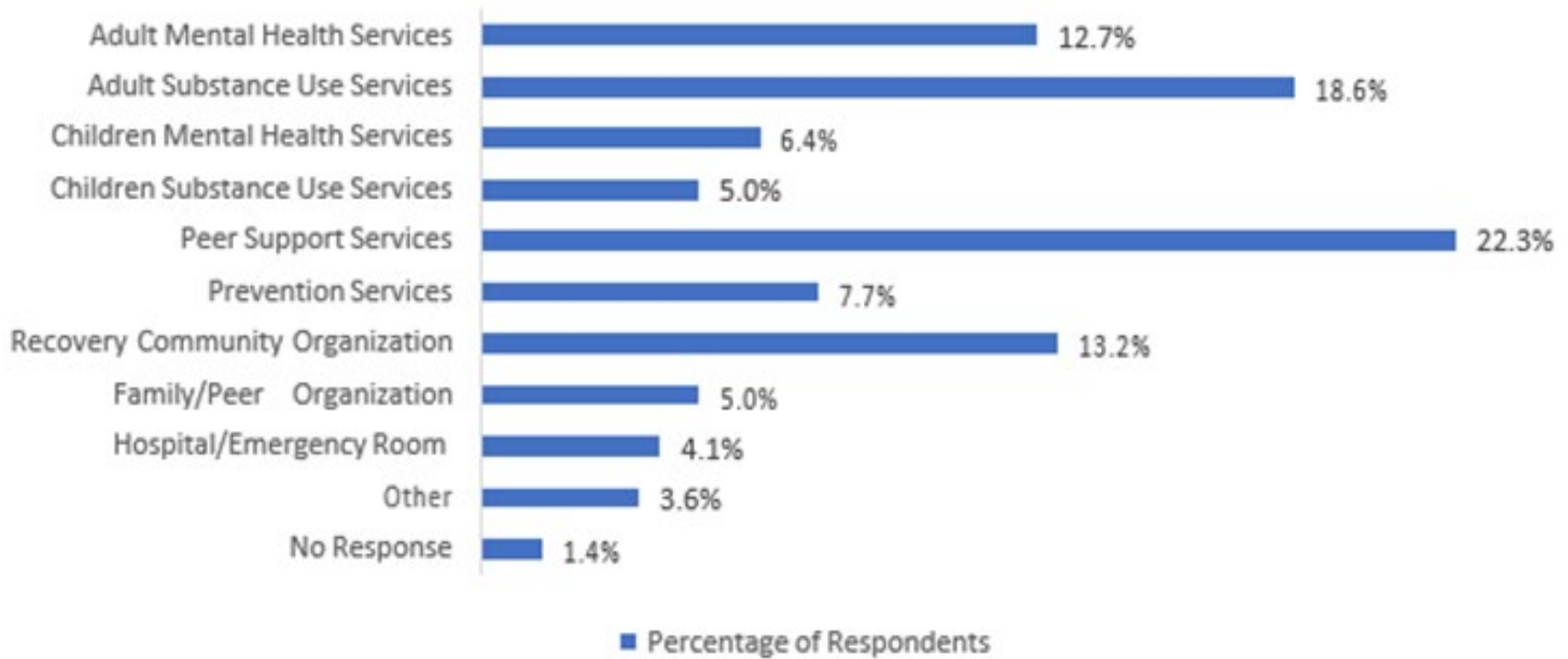

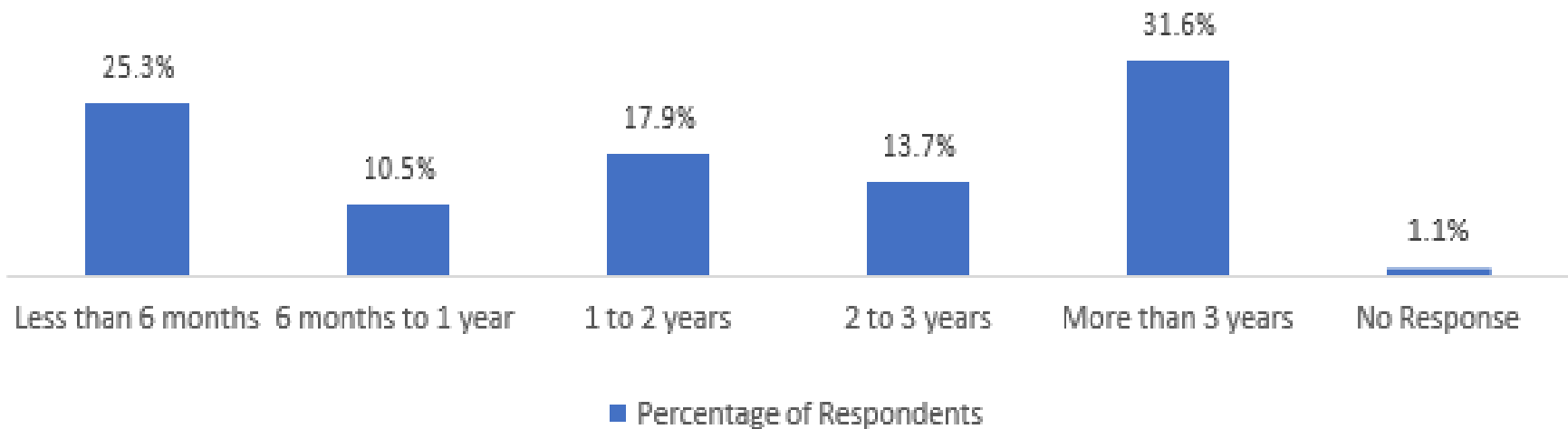

How long have you been employed/volunteered with the agency?

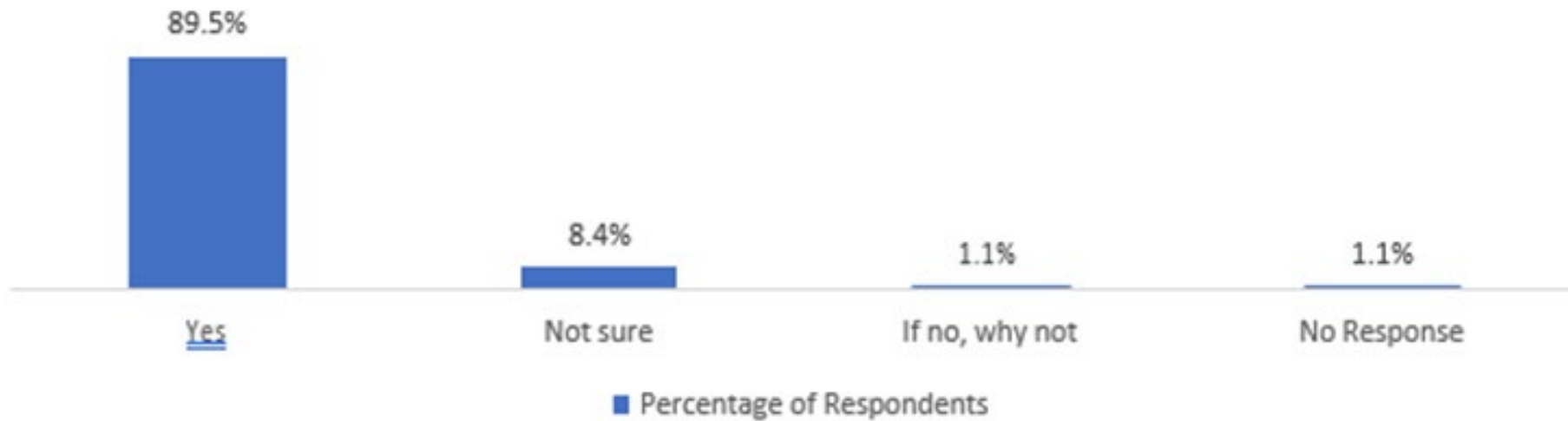

Does the agency where you are employed, or volunteer, use recovery peer support services within the services they provide in the community?

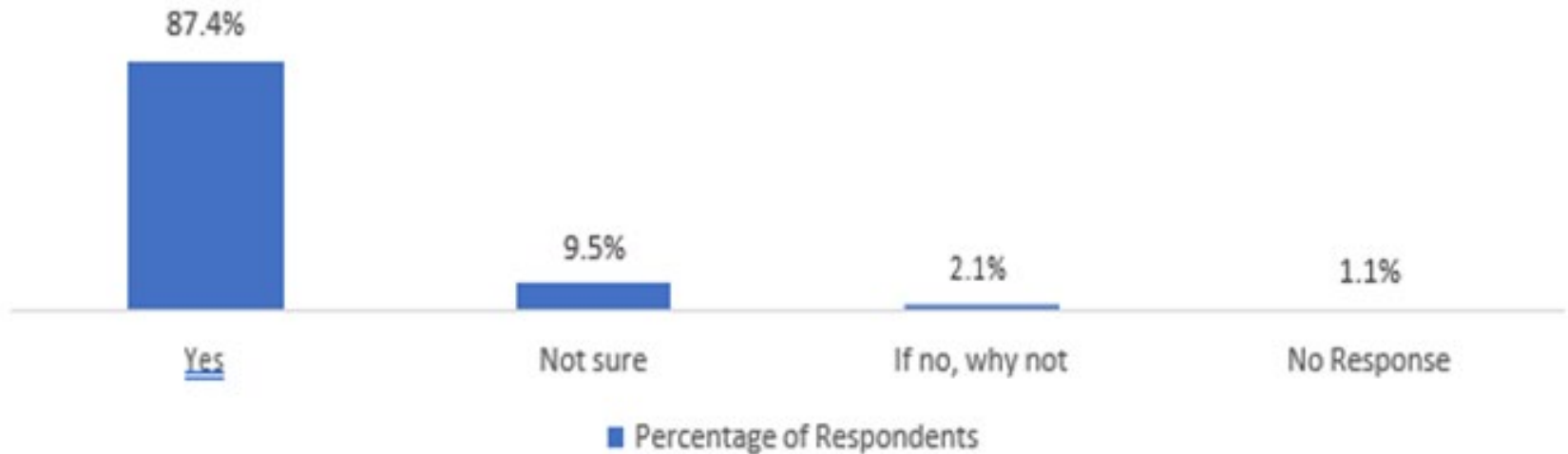

Does the agency where you are employed, volunteer, adhere to recovery support best practices?

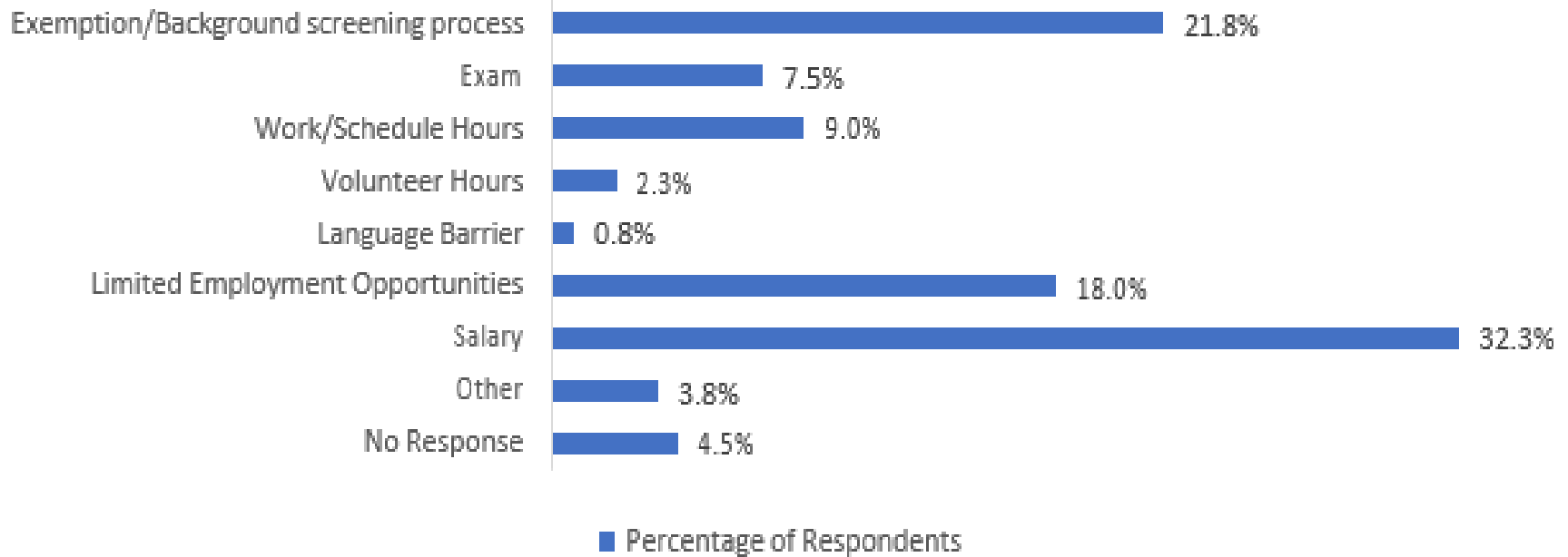

What barriers/challenges have you experienced in the hiring process? (Check all that apply)

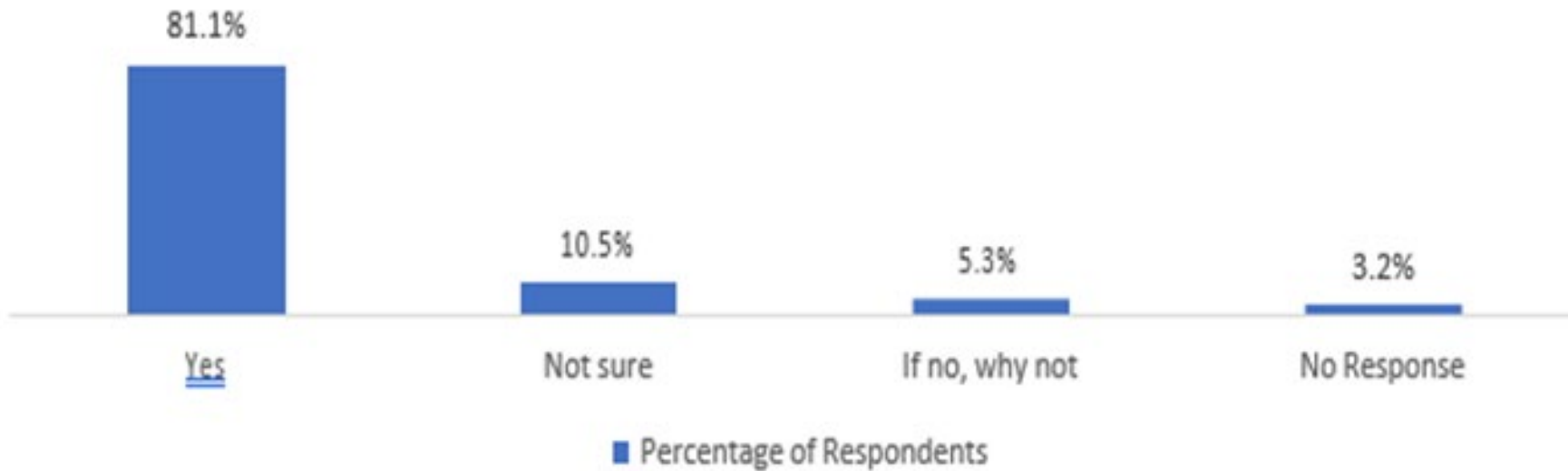

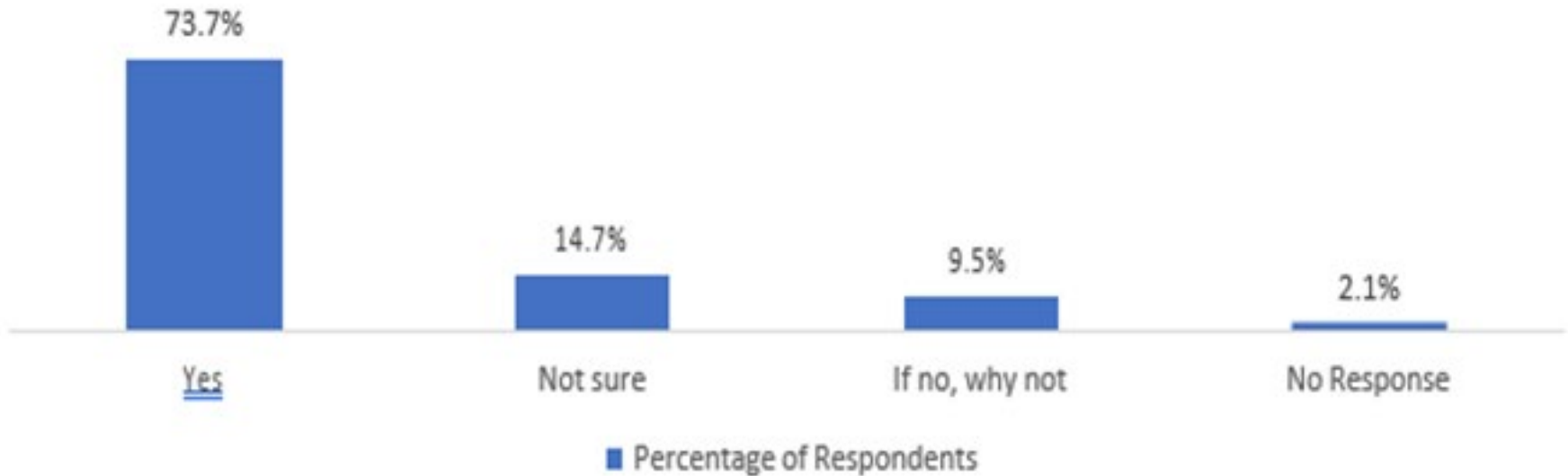


Does the organization where you are employed/volunteer with help to reduce stigma by promoting recovery language that is patient centered?

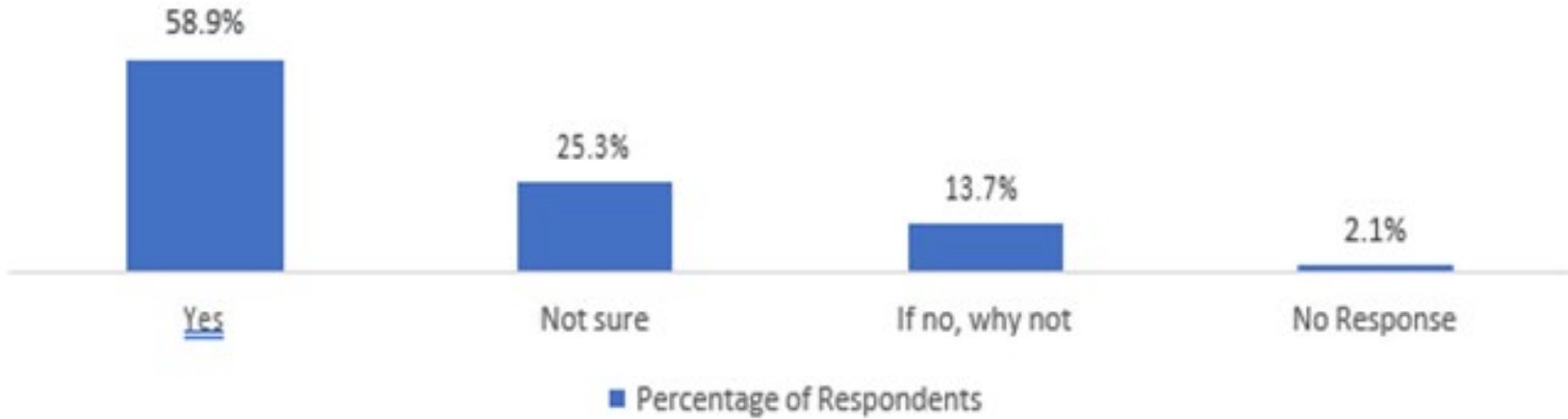




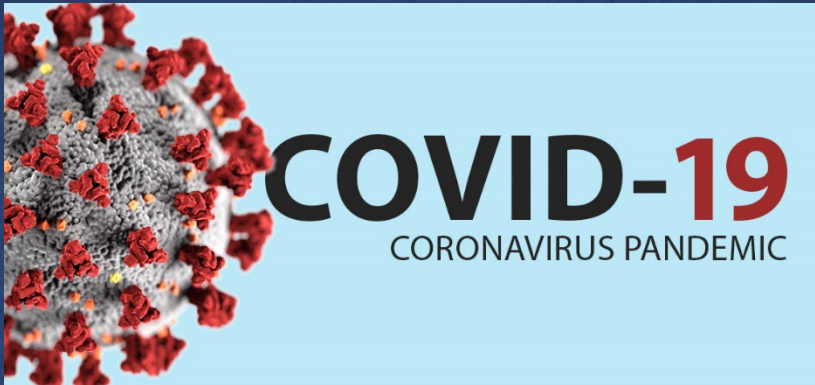

- Co-Responder teams to respond with law enforcement to divert from CSU and Jail
- Increased access to services in rural areas
