- 1. Mental Health Offenders Program (Sulzbacher Program Description) 01- Eligibility Criteria-Is defendant currently charged with a non-violent misdemeanor, excluding DUI?
- 2. Mental Health Offenders Program (Sulzbacher Program Description) 02-Eligibility Criteria-Does the defendant have a severe mental illness that requires intensive wraparound services and has defendant been arrested four or more times since 2017?
- 3. Mental Health Offenders Program (Sulzbacher Program Description) 03-Eligibility -Criteria-During each of the proceeding arrests, has the defendant had a mental health designation?
- 4. Mental Health Offenders Program (Sulzbacher Program Description) 04-Eligibility Criteria- Defendant does not meet any of the following: designated as a sexual offender or sexual predator by the Florida Department of Law Enforcement, open felony case, and/or on felony probation or parole.
- 5. Mental Health Offenders Program (Sulzbacher Program Description) 05-Eligibility Criteria-The defendant does not meet the exclusionary criteria; offenses listed in Section 948.06(8)(c). (1) Kidnapping or attempted kidnapping under s. 787.01, false imprisonment of a child under the age of 13 under s. 787.02(3), or luring or enticing a child under s. 787.025(2)(b) or (c).
- 2.Murder or attempted murder under s. 782.04, attempted felony murder under s. 782.051, or manslaughter under s. 782.07.
- 3. Aggravated battery or attempted aggravated battery under s. 784.045.
- 4.Sexual battery or attempted sexual battery under s. 794.011(2), (3), (4), or (8)(b) or (c).
- 5.Lewd or lascivious battery or attempted lewd or lascivious battery under s. 800.04(4), lewd or lascivious molestation under s. 800.04(5)(b) or (c)2., lewd or lascivious conduct under s. 800.04(6)(b), lewd or lascivious exhibition under s. 800.04(7)(b), or lewd or lascivious exhibition on computer under s. 847.0135(5)(b).
- 6.Robbery or attempted robbery under s. 812.13, carjacking or attempted carjacking under s. 812.133, or home invasion robbery or attempted home invasion robbery under s. 812.135.
- 7.Lewd or lascivious offense upon or in the presence of an elderly or disabled person or attempted lewd or lascivious offense upon or in the presence of an elderly or disabled person under s. 825.1025.
- 8. Sexual performance by a child or attempted sexual performance by a child under s. 827.071.
- 9. Computer pornography under s. 847.0135(2) or (3), transmission of child pornography under s. 847.0137, or selling or buying of minors under s. 847.0145.
- 10. Poisoning food or water under s. 859.01.
- 11. Abuse of a dead human body under s. 872.06.
- 12. Any burglary offense or attempted burglary offense that is either a first degree felony or second degree felony under s. 810.02(2) or (3).

- 7. Mental Health Offenders Program (Sulzbacher Program Description) 07-Referral Procedure- Was defendant identified in the jail and referred to MHOP during First Appearance?
- 8. Mental Health Offenders Program (Sulzbacher Program Description) 08-Screening- Was defendant screened by an MHOP team member to determine suitability for the program?
- 9. Mental Health Offenders Program (Sulzbacher Program Description) 09-Intake Process- did program supervisor request State Attorney's office run an out of state background check?
- 10. Mental Health Offenders Program (Sulzbacher Program Description) 10-Was a global medical release signed upon completion of screening if client was aggregable to services?
- 11. Mental Health Offenders Program (Sulzbacher Program Description) 11-Intake Process-Was a Sulzbacher representative present at first appearance to recommend MHOP?
- 12. Mental Health Offenders Program (Sulzbacher Program Description) 12-Intake Process-Was defendant released to the custody of a Sulzbacher representative by the 9 am the following day?
- 13. Mental Health Offenders Program (Sulzbacher Program Description) 13-Intake Process-Was the defendant immediately transported to Sulzbacher to receive a psychiatric evaluation and immediately given medication (usually a long acting injectable antipsychotic)?
- 14. Mental Health Offenders Program (Sulzbacher Program Description) 14-Intake Process- If homeless, has Sulzbacher placed the defendant in a motel and assisted with basic needs? OR if the defendant has stable housing, has Sulzbacher arranged transportation to their residence?

- 17. Mental Health Offenders Program (Sulzbacher Program Description) 17-Intake Process-If a judge denied defendant for MHOP has Sulzbacher notified the MHOP Coordinator?
- 18. Mental Health Offenders Program (Sulzbacher Program Description) 18-Service Delivery- have the defendant and family, if applicable, been included in the initial and follow up assessments?
- 19. Mental Health Offenders Program (Sulzbacher Program Description) 19-Service Delivery-Does the MHOP team meet weekly (or more if needed) to discuss defendant's care?
- 20. Mental Health Offenders Program (Sulzbacher Program Description) 20-Service Delivery- Has the Peer Support Specialist completed a WRAP plan with defendant?
- 21. Mental Health Offenders Program (Sulzbacher Program Description) 21-Discharge-was discharge a warm handoff and was follow up conducted until client was fully transitioned?
